

Call for Nominations 2016-2017 AAA Nominations Committee Nominations Deadline: 12:00 pm EST on Monday, March 7, 2016

It is the responsibility of the AAA Nominations Committee to select candidates and present a slate of qualified, acceptable candidates to the membership for a vote.

Members of the Association are invited to nominate an AAA Member and/or themselves as candidates for the 2016-2017 AAA Nominations Committee. The five elected members may <u>not</u> be current members of either the Council or the Board of Directors. All potential nominees must be active members in good standing.

Key Leadership Roles and Responsibilities of the AAA Nominations Committee:

- Nominate and select candidates for Board of Directors positions for election by the membership in Spring 2017.
- Members of the Nominations Committee are not eligible for nomination to the Board of Directors during their term on the Nominations Committee.
- The committee consists of the two most recent Past Presidents and five members elected by Council for a one-year term beginning August 2016.
- The Committee meets in-person once a year in late October or November; and holds 2-3 conference calls between March and November.

Council will elect the Nominations Committee members following the March Council Meeting.
