Manuscripts should be submitted in MS-Word format (1x blind copy & 1x copy with authors' details) to: j.cae@polyu.edu.hk. Please state clearly that the manuscript is to be submitted for the Plenary Sessions, Concurrent Sessions, or Special Sessions for Malaysian Studies.

Papers accepted for Plenary Sessions will be published in the JCAE, subject to satisfactory revisions and acceptance by the Editors. Authors are required to sign a copyright release form as a condition of publication.

The Symposium will provide accommodation (single occupancy) for three days, waiver of registration fees, and reimbursement for a return economy class airfare of a maximum of USD1,200 for one author of each accepted Plenary Session paper.

Best Paper Award: The best paper for the Plenary Paper Sessions will receive a cash award of USD1,000.

Authors who do not wish to commit their papers to the Journal should submit their papers for consideration at the Concurrent Paper Sessions / Special Sessions for Malaysian Studies. Plenary submissions not selected for Plenary Sessions will be considered for the Concurrent Paper Sessions. Authors who do not wish their papers to be considered for Concurrent Paper Sessions should clearly state this in their submission.

DOCTORAL CONSORTIUM

The Doctoral Consortium provides an opportunity for students to present their proposals and interact with renowned professors of international standing.
