The additional access to the wider AAA membership furthers the mission of the section as new colleagues are exposed to our discipline, which uniquely stretches across topics in all the other sections. # Remembering Former Trustee, Malcolm Anderson

It was with great sadness that Cardiff Business School learnt of the untimely death of Malcolm Anderson on 19 February 2018.

Malcolm was born on 22 January 1970. He grew up in Cramlington, Northumberland. Malcolm came to Cardiff as an undergraduate in the autumn of 1988. He read Economics and Economic History, graduating with First Class Honours in 1991. He was immediately recruited as a research assistant in the newly-formed Business History Research Unit led by Dick Edwards and Trevor Boyns. Malcolm quickly displayed his aptitude for academic research. He found his niche in the rather esoteric area of accounting history. With Dick and Roy Chandler, he investigated the perennial problem of the auditors' responsibility for detecting fraud. This enquiry had impact at the time of the Polly Peck and Maxwell corporate scandals; in 1993 their published results won the prize for the best paper in *Accounting and Business Research*.

The first major project on which he assisted was an ESRC-financed project headed by Dick and Trevor on the topic of 'The development of accounting information as the basis for management decision making' which lasted between August 1992 and April 1995. He became an important part of the 'Cardiff School' of accounting and business historians, making significant contributions to

the research efforts of the Unit, working alongside Dick, Trevor and Derek Matthews, with whom, in various combinations, he contributed to a number of journal and book publications in the 1990s. Over the next 15 years, he developed a body of work which ranged from widely read professional journals to some of the top 3- and 4-star journals with a more select readership. A piece that he particularly liked was his collaboration with eminent scholars who were not Cardiff-based, Stephen Zeff and the late Bob Parker, *Major Contributors to the British Accountancy Profession: A biographical sourcebook*.

Despite his impressive research output, Malcolm will be best remembered for his passionate dedication to learning and teaching, and in the pastoral support he provided to many current and past students. Malcolm was an excellent teacher with the rare ability to enthuse the large numbers of students who attended his lectures even on topics that could be technical and, of themselves, not especially inspiring. Starting with the award for the Most Effective Teacher in Cardiff University in 2011, Malcolm won an award every year whether for teaching excellence, feedback or student support.

The sense of loss his colleagues feel at his passing cannot be measured but is insignificant next to that felt by his wife Diane and his three daughters, Hannah, Rachel and Bethan, to whom he was devoted, and by the rest of his family.

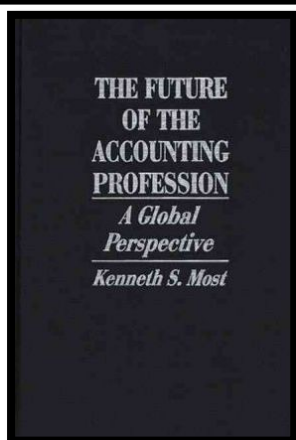

## Remembering Former Trustee, Kenneth S. Most

Dr. Kenneth S. Most, age 93, died on Thursday, Nov. 2, 2017 in South Florida. A native of the UK, Dr. Most received an LLB from the Univ. of London, an MA in Accounting and a PhD in Economics from the University of Florida. He was a Chartered Accountant (England & Wales) and a CPA (US). He taught at the Polytechnic of Central London, Singapore Univ., the Univ. of Florida, and Texas A&M Univ. He retired as Professor Emeritus from Florida International University in Miami. He was a past Grand Master of the Fraternal Order of Masons. A renowned scholar, he authored 20 books and over 100 articles in professional journals.

Predeceased by his wife of 67 years, Eva Kay, and son Giles. Survived by his daughter Caroline Elder and husband Dave, their sons Grant and Scott, and daughter Josephine Barhouma and husband Alf.

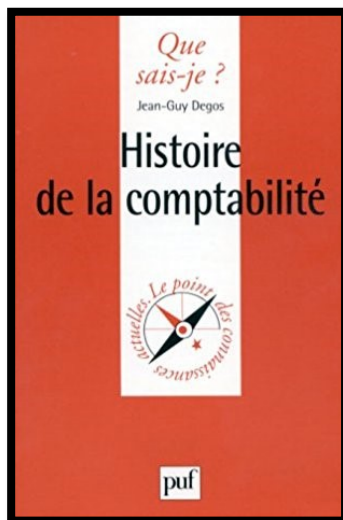


## Remembering Longtime Member, Jean-Guy Degos

Prof. Jean-Guy Degos was born on February 1, 1944 in Bordeaux, France and he passed on June 7, 2017 in Gradignan, France.

Professor Jean-Guy Degos taught at the University of Montesquieu - Bardeuz IV and was also the University's Director of Research for CRECCI. His research areas included the integration of assessment and history of accountants in the public accounting profession. He was a regular attendee of various accounting conferences, including several in the United States.

Jean-Guy was a dear friend to the Academy, as he was a dedicated and involved member of the Academy of Accounting Historians for many years--his presence at Academy events will be sorely missed.

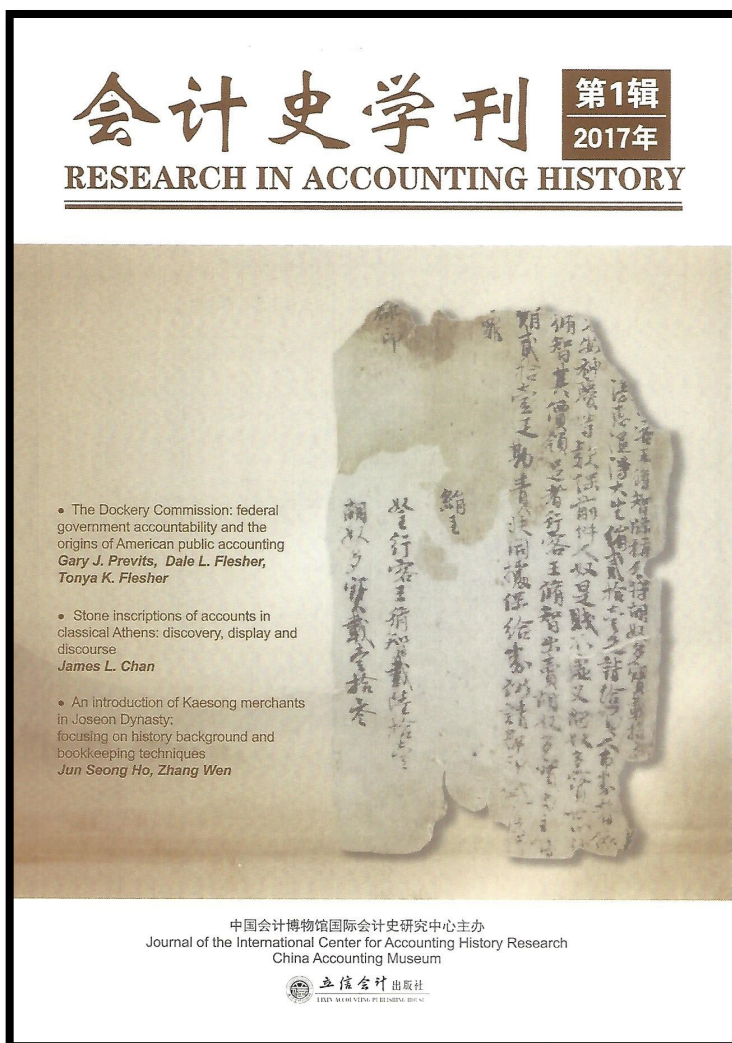
there will be opportunities to hear from many in our section at various sessions – look for program details coming soon!

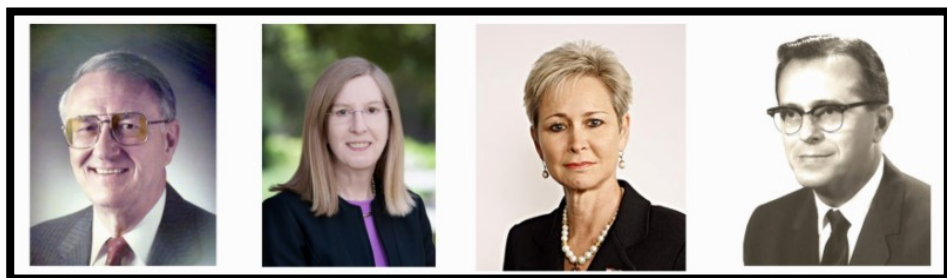

## Congratulations to the 2018 Accounting Hall of Fame Inductees

Four new members of The Accounting Hall of Fame will be inducted by the American Accounting Association in August 2018 during the Annual Meeting. The Hall of Fame originated at The Ohio State University in 1950, and has inducted 93 members over the decades of its activity. In 2017, the operations of the Accounting Hall of Fame were assumed by the AAA.



Bruce Behn, a Past President of AAA, who directed the selection process, noted that this year's class of inductees represent an array of recent and contemporary professional and thought leaders from a variety of practice and educational backgrounds. The nomination process engaged members of the Hall of Fame, the AAA and other professional accounting organizations. The inductees, pictured above, left to right, are George D. Anderson, Mary E. Barth, Olivia F. Kirtley and Kenneth W. Stringer.

**George David Anderson** (1922-2001) was a founding partner of Anderson & ZurMuehlen Co. PC of Helena Montana. He served as President of the Montana Society of CPAs, and as Chairman of the Board (1981-82) of the American Institute of Certified Public Accountants (AICPA).

**Mary Elizabeth Barth** is the Joan E. Horngren Professor of Accounting at Stanford University. Her contributions include serving as a member of the Accounting Standards Executive Committee of the AICPA.

**Olivia Faulkner Kirtley** served as the Chief Financial Officer and Vice President of Vermont American Corporation from 1991 to 2000. Her corporate board activity includes U.S. Bancorp, Papa John's International, and Rescare, Inc. among others.

**Kenneth Wilson Stringer** (1918-2014) spent his public accounting career with Deloitte and its predecessor firm, Haskins & Sells, advancing the processes supporting statistical sampling in auditing and analytical review.

# Updates from Turkey

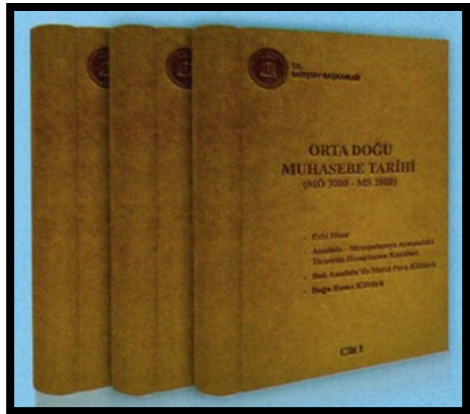
## Prof. Oktay Guvemli

Last fall, the Department of Accounting and Analysis at the St. Petersburg State University of Economics and the Oktay Guvemli Foundation for Finance and Accounting Studies organized an internship for young scholars doing historical research of accounting reporting and finance. Two graduate students from St. Petersburg State University of Economics, Irina Alekseevna and Irina Nikolaevna, participated in the internship that ran from October 9 - 29, 2017. The purpose of the internship: prepare young researchers to participate in the 2020 World Congress of Accounting Historians, which for the first time will take place in Russia at the St. Petersburg State University of Economics.

Both Ms. Alekseevna and Ms. Nikolaevna performed research under the guidance of Prof. Guvemli. They also took part in meetings with Jelali Imazom, an employee of the Turkish Stock Exchange and were also able to attend and participate in the international conference for accounting reporting, finance, and auditing at the

University of Edirne in Turkey.

The internship program was led by Prof. Vecheslav Sokolov and associate professor, Elean Abdalove. The success of this internship led Prof. Guvemli to encourage additional internships over the next three years leading up to the conference in St. Petersburg.

## **Hourglass Award**

The Hourglass Award of the Academy of Accounting Historians is presented annually to an individual who has made a demonstrable and significant contribution to knowledge through research and publication in accounting history. The judging panel will echo the tradition of openness and flexibility associated with the Award and will emphasize the importance of contribution as the fundamental criterion. To that end there is no restriction as to who may make a nomination, the country in which the nominee is resident, or the paradigms and methodologies employed in the nominee's work. Nominators are asked to supply a 200-word (maximum) statement summarizing the reasons why the nominee should be considered, full contact details of the nominator and nominee and a list of relevant contributions and any other relevant documentation supplied by the nominee who has agreed to be nominated.

## **The Vangermeersch Manuscript Award**

In 1988, The Academy of Accounting Historians established an annual manuscript award to encourage scholars new to the field to pursue historical research. An historical manuscript on any aspect of the field of accounting, broadly defined, is appropriate for submission.

### **Eligibility and Guidelines for Submissions**

Any accounting faculty member, who holds a full-time appointment and who received his/her masters/doctorate within seven years previous to the date of submission, is eligible to be considered for this award. Coauthored manuscripts will be considered (if at least one coauthor received his/her master/doctorate within the last seven years). Manuscripts must conform to the style requirements of the *Accounting Historians Journal*. Previously published manuscripts or manuscripts under review are not eligible for consideration. A cover letter, indicating the author's mailing address, the date of the award of the masters/doctoral degree, and a statement that the manuscript has not been published or is not currently being considered for publication should be included in the submission packet. Submissions should be sent as a Word attachment via email.

### Review Process and Award

The committee will evaluate submitted manuscripts on a blind-review basis and select one recipient each year. The author will receive a \$500 stipend and a plaque to recognize his/her outstanding achievement in historical research. In the case of coauthored manuscripts, only the junior faculty member(s) will receive prizes. The winning manuscript will be published in the *Accounting Historians Journal* after an appropriate review. The award will be given annually unless the committee determines that no submission warrants recognition as an outstanding manuscript.

### **Barbara D. Merino Award for Excellence in Accounting History Publication**

This newly established annual award is to recognize the author of the best book on an accounting historical topic published in a given year. Beginning in 2013, an annual award in the amount of \$1000 has been made to the author of the best book published in current or preceding two years, i.e. 2015 through 2017. The winning publication will be based upon the selection of an awards committee established by the leadership of the Academy.

### **The Alfred R. Roberts Memorial Research Award**

This newly established award is named in honor of Dr. Alfred R. Roberts, second President and long serving Secretary of the Academy, and provides grants for research which seek to support the 35 goals identified by Professor Emeritus Richard Vangermeersch as to accounting history research, as identified in the April 2012 issue of the *Accounting Historians Notebook*. Grants will be awarded to Academy members for the actualization of ideas to increase the scope of the history of accounting. Written proposals including specification of scope, purpose, deliverables and timetable, should be presented to the committee for review and approval.

### **The Innovation in Accounting History Education Award**

The intent of the Innovation in Accounting History Education Award is to encourage innovations in accounting history education. The award is presented to an individual(s) who has developed and implemented an innovative technique/method for incorporating accounting history topics into undergraduate or graduate accounting courses.

Examples of innovative techniques/methods include, but are not limited to:

- Developing a case, video, audio or course syllabus, etc, that can be used to integrate accounting history topics into accounting courses; or
- Presenting a seminar/condensed course on an accounting history topic.

To be eligible, the innovation must have been used in a course that the applicant has taught or is currently teaching. Electronic submissions should include the following items (as applicable):

- A description of the innovative technique/method;
- Submission of the case, video, audio or other innovation, as appropriate, and teaching notes;
- Identification and description of the course or seminar in which the innovation was used; and
- An explanation of how the innovation has enriched the accounting course being taught.

### **The Margit F. and Hanns Martin Schoenfeld Scholarship**

The Academy of Accounting Historians annually awards an individual or individuals as the recipient or recipients of the Margit F. and Hanns Martin Schoenfeld Scholarship. The purpose of the scholarship is to encourage and support research on the history of accounting by doctoral students and recently appointed accounting faculty. The scholarship was initiated by the generous gift of Dr. Hanns Martin Schoenfeld and the late Dr. Margit Schoenfeld in recognition of their belief in the importance of historical scholarship to accounting education and research.

A monetary award is available to support research on a doctoral dissertation, or develop publications proceeding therefrom by a recent PhD graduate. Qualifying research topics should address the history of accounting. Projects of an international nature and those pursued by scholars whose first language is not English are particularly invited. Applicants must be currently enrolled for a PhD by research, or have completed a PhD by research within the last five years.

Applicants should submit a full curriculum vitae and a statement (containing a maximum of 1,000 words) which discusses the doctoral research undertaken on the history of accounting, the stage reached and how the award would prove beneficial to the applicant. A short statement from a supervisor should also be submitted in the case of applicants currently enrolled for a PhD.

### **Thomas J. Burns Biographical Research Award**

The Academy of Accounting Historians annually honors an individual as the recipient of the Thomas J. Burns Biographical Research Award. The Award is given for outstanding biographical research in the discipline of accountancy. The award includes a plaque and a financial award. Dr. Thomas J. Burns, for whom the award is named, was a long-time professor at Ohio State University and a past president of the Academy of Accounting Historians. Self nomina-

tions are acceptable. Nominations should be accompanied by a paragraph or more detailing why the nominee should be a candidate for the award. The award can be for a single publication or for a lifetime of biographical work.

### **The Best Manuscript Award**

At the beginning of each year, the editor of the AHJ chooses 1st, 2nd and 3rd place recipients of the Best Manuscript Award from the previous year's journals. The 1<sup>st</sup> place recipient(s) receives a plaque and a check for \$300, the 2<sup>nd</sup> place recipient(s) receives a check for \$100 and the 3<sup>rd</sup> place recipient(s) receives a check for \$100.
