2019 Annual Meeting Welcome from 2018-2019 AAA President Marc A. Rubin

It is my honor to invite you to the 103rd Annual Meeting of the American Accounting Association (AAA) to be held August 9-14, 2019 in San Francisco, California. The theme for this year's Annual Meeting is "Bold Transformations Toward a Prosperous Society." We are facing change at a faster pace than we have ever witnessed. The development of new technologies is having a profound impact on the demand for new goods and services as well as how organizations operate. A recent study indicates that two industries of interest, professional services and higher education, will be disrupted to a great degree and in a relatively short amount of time. Will online education as well as the use of artificial intelligence, machine learning, robots, virtual reality, mobile technology, 3-D printing, and future technologies that we cannot even imagine cause the accounting academy to redefine what we teach and research, as well as how we teach and research? Many of the speakers in San Francisco will address how the many potential disruptions may affect our academy. The Annual Meeting is one of the best opportunities for our membership to network, present research and teaching ideas, and discover the latest academy trends.

Pre-meeting activities begin on Friday, August 9, with the *Transformative Technologies Workshop* and continue with a variety of sessions and workshops on Saturday and Sunday, including the **Conference on Teaching and Learning (CTLA)**, before the meeting officially gets under way on Monday, August 12.

The plenaries and concurrent sessions will take place from Monday morning, August 12, through the evening of Wednesday, August 14, and will feature an array of discussions, panels, and events. The Monday morning plenary will feature **Goldie Blumenstyk**, a senior writer for *The Chronicle of Higher Education*. She is a nationally known expert on the business of higher education, for-profit colleges, and innovation in and around academe. A winner of multiple awards from the Education Writers Association, she has reported for *The Chronicle* from China, Europe, Israel, and Peru, and has contributed to *The New York Times* and *USA Today*.

The 2019 Presidential Scholar, **Erik Brynjolfsson**, will be the speaker at the Tuesday morning plenary session. He is director of the Massachusetts Institute of Technology's (MIT) Initiative on the Digital Economy, professor at MIT Sloan School of Management, and research associate at the National Bureau of Economic Research (NBER). His research examines the effects of information technologies on business strategy, productivity and performance, digital commerce, pricing models, and intangible assets. He is the author of several books including, with co-author Andrew McAfee, *The New York Times* bestseller *The Second Machine Age: Work, Progress, and Prosperity in a Time of Brilliant Technologies* (2014) and *Machine, Platform, Crowd: Harnessing Our Digital Future* (June 2017). Our Tuesday luncheon speaker will be sociologist **Bertice Berry**, Ph.D., who is an award-winning lecturer and best-selling author, who has been named Comedian of the Year, Lecturer of the Year, and Entertainer of the Year. She has published 11 best-selling books in both fiction and non-fiction, and has won numerous awards and accolades for both her writing and presentations.

Wednesday's plenary will feature **Daniel Newman**, the principal analyst of Futurum Research and the CEO of Broadsuite Media Group. Daniel works with the world's largest technology brands exploring digital transformation and how it is influencing the enterprise.

From Big Data, to IoT, to Cloud Computing, Newman makes the connections between business, people, and tech that are required for companies to benefit most from their technology projects, which leads to his ideas regularly being cited in *The London Times, CIO Review*, on CNBC, and hundreds of other sites across the world. A six-time best-selling author, including his most recent *Futureproof: 7 Key Pillars for Digital Transformation Success*, Daniel is also a *Forbes, Entrepreneur*, and *Huffington Post* contributor.

Goldie Blumenstyk joined *The Chronicle of Higher Education* in 1988. Now a senior writer, she is a nationally known expert on the business of higher education, for profit-colleges, and innovation in and around academe. Erik Brynjolfsson is director and co-founder of the Massachusetts Institute of Technology's (MIT) Initiative on the Digital Economy, Schussel Family professor at MIT Sloan School, and research associate at the National Bureau of Economic Research (NBER). His research examines the effects of information technologies on business strategy, productivity and performance, digital commerce, pricing models, and intangible assets. Brynjolfsson was among the first researchers to measure productivity contributions of IT and the complementary role of organizational capital and other intangibles. At MIT, he teaches courses on the Economics of Information and the Analytics Lab.

Author of several books including, with co-author Andrew McAfee, *The New York Times* best-seller *The Second Machine Age: Work, Progress and Prosperity in a Time of Brilliant Technologies* (2014) and *Machine, Platform, Crowd: Harnessing Our Digital Future* (2017), Brynjolfsson is editor of the Social Science Research Network's (SSRN) Information System Network and has served on editorial boards of numerous academic journals. He holds Bachelor's and Master's degrees from Harvard University in applied mathematics and decision sciences and a Ph.D. from MIT in managerial economics.

Terry earned his Ph.D. from Stanford University in 1986 and joined the faculty at the University of Washington where he worked for 26 years until joining the University of California, Irvine (UCI) in the summer of 2012. He holds a Paul Merage Chair in Business and he is associate dean for research and doctoral programs at the Merage School of Business at UCI. He held the Paul Pigott/Paccar Professor of Business Administration from 2004-2012. While at Washington, he held various administrative position: faculty director of the PhD Pogram 1998-2006 and Accounting Department Chair from 2006-2012.

He has received a number of awards for his research and mentoring of Ph.D. students, the most recent being named the American Accounting Association's Outstanding Educator for 2012. He was also named the American Taxation Association 2005 Ray M. Sommerfeld Outstanding Tax Educator. He has won the American Taxation Association Tax Manuscript Award 3 times (in 2004, 1995, and 1992) and twice won the AAA Competitive Manuscript for young scholars (1990 and 1987). He has been awarded the UW Business School Dean's Faculty Research

Award 4 times.

His research interests are broad and include the effect of taxes on business decisions and asset prices, capital markets-based accounting research, earnings management, research design, and statistical significance testing issues.

In addition to the above-listed plenary and luncheon speakers, the concurrent sessions during the Annual Meeting will include some thought-provoking At-Large panel sessions that we hope you will be able to attend. The meeting will also feature the sixth annual Global Emerging Scholars Research Workshop, which will be held on Sunday, and the Faculty-Student Collaborations in Accounting (FASTCA-19), which will be held on Wednesday.

The 2019 Yuji Ijiri Lecture on Foundations of Accounting

This year the AAA is host to the second annual **Yuji Ijiri Lecture on Foundations of Accounting**, an honor and event sponsored by five international associations. With presentations rotating annually between the sponsoring groups around the globe, the 2019 lecture will be given by Sudipta Basu, of the Fox School of Business at Temple University.

Founded by five international sponsoring organizations, this memorial lecture honors Yuji Ijiri (1935-2017), a premier accounting thought leader of the twentieth century, by showcasing ideas and research on foundations of accounting from all parts of the world. The inaugural lecture was given last year at the Japan Accounting Association's meeting by Professor Shizuki Saito.

After attending Doshisha Junior College, and Ritsumeikan University in Kyoto, Yuji became the youngest person in Japan to complete all requirements for the CPA. He moved to the US to complete a PhD and join the faculty at Carnegie Mellon University as the R.M. Trueblood Professor of Accounting and Economics (with a four-year stint at Stanford along the way) where he mentored generations of doctoral students and worked with colleagues around the world.

Professor Ijiri was a Past President of the American Accounting Association (AAA), and the youngest inductee into the Accounting Hall of Fame. He was the only four-time recipient of the AAA's Notable Contributions to Accounting Literature Award, and over his career published 200 papers and 25 books building ideas and knowledge in accounting.

The sponsoring associations, being devoted to the advancement of accounting thought, joined together to honor Yuji Ijiri's contributions by establishing and organizing a rotating lecture to be delivered during the annual meetings of the participating organizations:

What Is ShelterBox?

ShelterBox is the premier international disaster relief charity that provides immediate emergency shelter and other lifesaving aid to survivors of disasters such as earthquakes, volcanoes, floods, droughts, hurricanes, tsunamis, or humanitarian crises. ShelterBox aid is tailored to each disaster but typically includes tented shelter, thermal blankets and groundsheets, water purification equipment, solar lights, cooking utensils, a tool kit, mosquito nets, and children's activity packs.

ShelterBox Response Team members are highly trained civilian volunteers who deploy with the aid and ensure it is delivered to the survivors who need it most. They distribute aid on the ground, working closely with local organizations, government officials, and international aid agencies. ShelterBox aid is transported by any means available: truck, boat, camel, sled, or by hand. Since 2000, ShelterBox has helped 1.2 million people by providing emergency shelter following more than 300 disasters in 95 countries.

The Aid They Deliver

March 2019 - A ShelterBox Response Team is in southern Africa after Cyclone Idai caused widespread flooding in Malawi, Zimbabwe, and Mozambique on March 14, bringing winds of over 100 mph. More than one million people have been affected and at least 125,000 have been forced from their homes in Malawi alone. According to the UN, this devastating cyclone may be the worst disaster to ever hit the Southern Hemisphere. Downpours have been affecting the region for weeks, causing severe floods since the beginning of March. This comes after a period of severe drought, making the conditions worse.

In 2018, ShelterBox responded 18 times to different disasters in 17 countries and assisted over 210,000 people worldwide, including in 8 conflict responses in Syria, Iraq, Chad, Cameroon, Niger, and Nigeria; 4 tropical cyclones in Indonesia and the Philippines; 2 floods in Ethiopia and Kenya; 2 earthquakes in Indonesia; 1 drought in Somaliland; and 1 volcano in Guatemala.

In 2017, ShelterBox assisted 160,000 people worldwide including in the U.S. in Texas after Hurricane Harvey, in 6 countries in the Caribbean after Hurricanes Irma and Maria, in 7 countries affected by conflict-associated displacement, and numerous other countries affected by natural disasters and conflict.

ShelterBox has responded to some of the largest humanitarian crises the modern world has ever known: Hurricane Matthew in Haiti in 2016, the 2004 Indian Ocean tsunami, the 2010 Haiti earthquake, and one of the biggest storms to ever make landfall—Typhoon Haiyan in the Philippines in 2013.

What Is the Service Project?

The Service Project was born out of the generous nature of the AAA's members and their desire to give back to the local communities in the cities where the Annual Meeting was held. From 2011 through 2016, on behalf of its members, the AAA supported local communities with donations of thousands of new backpacks filled with school supplies.

In 2017, the AAA began taking a more global approach to giving back and helping those who may otherwise go without by partnering with ShelterBox.
