An Executive Session was held from 8:30 am - 9:20 am.

Minutes

A. Welcome – Christine Botosan welcomed the Board members and guests to the Board meeting. The agenda was reviewed and no additions/changes were made.

MSC to approve the minutes of the 2015 May Board of Directors meeting.

- B. Annual Meeting: Key Messaging for Engaging our Community The messaging for the Annual Meeting reflected on our past, present and future. Christine Botosan reviewed the Sharpening Our Vision project and timeline. The Board along with Council, and 51 members serving on 4 task forces, conducted an in-depth environmental scan and generated over 50 unique ideas to take advantage of the changes happening in the world of higher education. Julie Smith David reminded the Board of the presentation Bruce Mau Design (BMD) made at the 2015 May Strategic Retreat. The AAA is celebrating its 100th anniversary. This event is a major milestone in the AAA history and this is an opportunity at the Annual Meeting to engage members to encourage their support of the changes in the world of higher education, including the possibility of an Association name change.
- C. Executive Director's Report Tracey Sutherland reported on projects that were in process at the time of our March Meeting. The purchase of a building for the AAA Headquarters, the launching of two new journals, *Journal of Forensic Accounting Research* and *The Journal of Financial Reporting*. There was an upgrade to our association management system and the content management system, and the approval of an historic budget. The renovation plan for the new headquarters is being finalized with a target move-in date of April 2016. She reported on the upcoming retirement of Diane Hazard, Director of Publications, and reminded everyone of the new professional leadership staff, Susan Crosson, Director of the Center for Advancing Accounting Education, and Jeremy Thompson, Membership and Communications Director. Erlinda Jones, Senior Director of Member Event Services, has taken on additional on-site meeting responsibility while Dee Strahan is on sabbatical. Tracey talked about the official AAA mobile app that has been launched for the Annual Meeting. The official start of the Centennial celebration will take place at the Monday Plenary session with a flag procession. The J. Michael and Mary Anne Cook prize will be awarded for the first time at the Monday Plenary session. Three awards of \$25,000 each can be made in three categories: graduate degree program, undergraduate degree programs, and two-year degree programs. The Pathways Commission transition will be completed at the Annual Meeting. All attendees received a copy of the Pathways Commission report.

C. Executive Director's Report (continued) –William Ezzell and Mark Higgins will receive the Outstanding Service Award for their work as Co-Chairs of the Pathways Commission and Mary Stone will receive the award for her work as Chair of

the Publication Ethics Task Force. Tracey reported that on June 25th, 25 articles and one section of one article were retracted from across the AAA journal collection. She described the key elements of the retraction process.

- **D. Annual Meeting update** Tracey Sutherland reported there are about 100 more registrations than last year. There are 77 countries represented. Christine Botosan reviewed the Plenary and Lunch speakers. The Conference on Teaching and Learning, the TLC WOW event, Global Emerging Scholars Workshop and FASTCA-15 are continuing events.
- E. Finance Stephen Moerhle reviewed the 2014-2015 financial highlights.

H. Engaging our Communities

- 1. Section and Region Anne Christensen reported on attendance at the Spring Segment meetings. The Volunteer Leadership Workshop will have 41 leaders participate 24 from Sections, 14 from Regions and 3 Council leaders. Anne talked about the Strategic Region Leadership Committee and the issues they will be discussing at their upcoming meeting in September.
- 2. Global Gathering update Gary Biddle reported on the upcoming Global Gathering meeting that will be held on Thursday, August 13th.

I. Publications

Research Committee update – Steven Kachelmeier updated the Board on the status of the monographs. The Research
Committee also made recommendations for the Senior Scholar videos. The Research Committee was tasked by the
Board to consider any needed revisions to the published AAA Award Criteria. The Committee reviewed the eligibility
and the name of the AAA/Grant Thornton Doctoral Dissertation Awards for Innovation in Accounting Education.

MSC to accept the proposal to remove "third-or-fourth year" and to change the title to AAA/Grant Thornton Doctoral Dissertation Awards for Innovative Research in Accounting Education.

I. Publications (continued)

The Research Committee also reviewed the eligibility of multiple publications for the Notable Contributions to Accounting Literature Award, Distinguished Contribution to Accounting Literature Award, Seminal Contributions to Accounting Literature Award and AAA/Deloitte Wildman Awards.

MSC to accept the proposal and add the following new criterion to the Notable, Distinguished, Seminal, and

Wildman award criteria: "Although the award generally recognizes a single publication, two or more related publications (co)authored by the same nominee(s) may be considered for joint nomination if they stem from the same program of study that addresses a well-defined research objective. In this case, each related publication must comply with all other eligibility requirements. Nominations of multiple related publications should explain the single program of study that justifies considering the nominated publications as a whole."

- 2. Publications Committee update Terry Shevlin discussed that a survey will be conducted to gather information on how Editors from journals are selected. The process for selecting the Best Papers will be reviewed in the fall along with determining if there should be a Best Paper awarded for *The Accounting Review*. The Publications Committee will be changing their committee charge. Three Journal Steering committees will be formed for *The Accounting Review*, Accounting Horizons, and Issues in Accounting Education. The Journal Steering committees will focus on the mission of the journal and the nominations for editor for the respective journal. The Chairs of the Steering committees will also serve on the Publications Committee.
- J. Centers update Susan Crosson reported on the Accounting IS Big Data conference that is being held on September 3 & 4 in New York City. The conference has 50 participants from the practice community. There are mostly school teams of 3 representing teaching, research, and practice. 75 schools will be represented including global participants. Susan reported on The J. Michael and Mary Anne Cook Prize selection process and reminded everyone that the award winners will participate on a panel session on Monday, August 10. An update was given on reimagining content and speaking to society and the continuation of the conversation with Brian O'Leary from the 2015 May Strategic Retreat.
