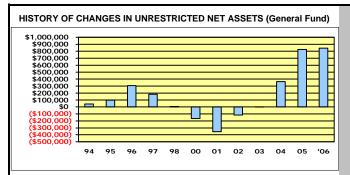
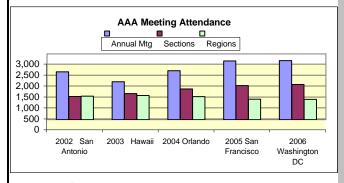
Key Performance Indicators American Accounting Association After Fiscal Year Ending 8/31/06

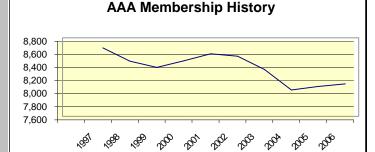

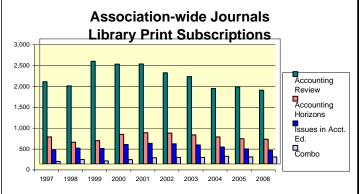
The fiscal year ending 8/31/06 showed an overall balance sheet improvement for the association as a whole. Contracts with journal aggregators Proquest and Ebsco will result in guaranteed royalties of \$350K per year through 2007, which have been designated by the Executive committee for future infrastructure, consulting services and other support for the AAA journal collection. Net inflows from the three main journals were higher than predicted and admin. expenses were less than budgeted.



Washington DC attracted the highest Annual Meeting attendance in recorded history -- 2,697. Upcoming Annual Mtgs. will be in Chicago, Orange County, CA and New York city.

The membership chart above shows a steady decline in membership from year to year with the exception of a temporary influx of new members in the 2001-02 period when membership promotion campaign was initiated with the help of a marketing company. The decline in membership was abated in 2005 by the number of new members attending the Annual Meeting and the increase in associate members in the past two years. The library subscription chart above shows a consistent decline in subscritions to hard copy association-wide journals while electronic subscriptions have increased as shown in the chart below. This trend is expected to continue as we promote the latter to libraries.
