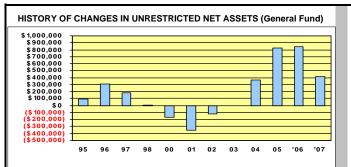
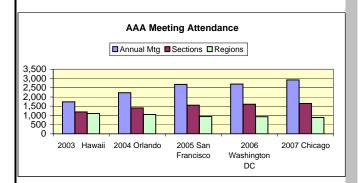
## Key Performance Indicators American Accounting Association After Fiscal Year Ending 8/31/07



Note that dues increases were imposed in 1996 and 2004, a budget crisis occurred in 2001and cost controls resulted in a breakeven budget in 2003. Included in the 2005 - 2007 surpluses is journal aggregator net revenue of \$554,934, \$322,578 and \$151,991 respectively, designated by the Executive Committee for future needs.

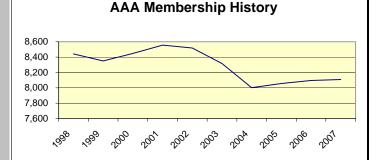

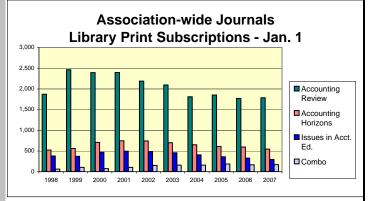
The fiscal year ending 8/31/07 showed an overall balance sheet improvement for the association as a whole. Contracts with journal aggregators will result in guaranteed royalties of \$350K per year through Dec. 2007, which have been designated by the Executive committee for future infrastructure, consulting services and other support for the AAA journal collection. Net inflows from the Annual Meeting, due to increased registrations and lower audio/visual costs, were higher than predicted and admin. expenses were less than budgeted.



Chicago attracted the highest Annual Meeting attendance in recorded history -- 2,924. Upcoming Annual Mtgs. will be in Anaheim, CA and New York city.

The membership chart above shows a steady decline in membership from year to year with the exception of a temporary influx of new members in the 2001-02 period when membership promotion campaign was initiated with the help of a marketing company. The decline in membership was abated in 2005 by the number of new members attending the Annual Meeting and the increase in associate members in the past three years. The library subscription chart above shows a consistent decline in subscritions to hard copy association-wide journals while electronic subscriptions have increased as shown in the chart below. This trend is expected to continue as we promote the latter to libraries. These counts dropped significantly in 2007 after the Jan. 1 comparison date when unpaid subscriptions where deactivated.
