SUBMISSION DEADLINE & NOTICE OF DECISIONS

Submissions should be received by Monday, July 6, 2015. All manuscripts are subject to a blind review process.

Email notification of the outcome of each submission will be sent to the corresponding author or authors in August, 2015.

CONFERENCE ARRANGEMENTS

The conference will be held at the Irvine Marriott Hotel in Irvine, California, about 5 minutes from the Orange County Airport (SNA).
