President's Invitation to San Francisco

I am delighted to invite you to the 2010 Annual Meeting of the American Accounting Association in San Francisco, California! The meeting begins on Sunday, August 1 and extends through Wednesday evening, August 4. Of course there are many pre-meeting activities, as well, including our third Conference on Teaching and Learning in Accounting, and so you may be spending as much as a week in California.

The theme for our meeting this year is "Global Thought Leadership." Many of you have heard me talking about this over the past several months. The AAA is and has long been a thought leader through our members' research, education, and service. In a global economy, and with a significant proportion of our membership outside the US, our members incorporate diverse perspectives and contribute to the advancement of accounting thought around the world.

In keeping with our theme, the Annual Meeting will begin on Monday with a plenary presentation by **Robert (Bob) Bunting**, President of the International Federation of Accountants (IFAC). This global organization's independent boards develop accounting standards in ethics, auditing, education, and public sector accounting. IFAC's members and associates represent more than 2 million accountants worldwide. Bob has been on the IFAC Board

since November 2005. Apart from his work at IFAC, Mr. Bunting is a Partner at Moss Adams LLP, where he was Chairman and Chief Executive Officer from 1982 – 2004. From 2004 to 2005, Bob chaired the American Institute of Certified Public Accountants (AICPA) Board of Directors and he has previously chaired the Audit Committee, Board of Examiners, and SEC Practice Section Executive Committee. He will talk about how accounting education and research can advance the profession as we meet the challenges of our global economy.

Tuesday morning's plenary speaker will be **James Kroeker**, recently appointed Chief Accountant of the Securities and Exchange Commission (SEC). Jim was previously a partner with Deloitte and Touche, LLP, having worked in the firm's National Office Accounting Services Group since 2002. His background also includes a stint as Practice Fellow at the Financial Accounting Standards Board. The SEC has a number of issues of interest to academics on its plate, including the proposed road map for adoption of International Financial Reporting Standards. Jim will provide us with the most current information on the status of that issue as well as others of particular interest to members of the accounting academy.

At the Wednesday morning plenary session **Bob Kaplan**, Baker Foundation Professor at Harvard Business School, will deliver the Presidential Scholar address. Perhaps best known for his work in developing the balanced scorecard and activity-based costing, Bob has contributed much to global thought leadership in accounting. He has published extensively in

strategy, financial, cost, and managerial accounting. He served as Dean of the Tepper School of Business at Carnegie Mellon University. In 2006, he was named to the Accounting Hall of Fame and received the Lifetime Contribution Award from the AAA's Management Accounting Section. Bob has promised a thought-provoking speech about the pressing need for accounting scholars to integrate the measurement of uncertainty in fair value accounting and risk management.

The Tuesday luncheon speaker is **Betsy Rafael** the Vice President Corporate Controller and Principal Accounting Officer of Apple, Inc. At the Wednesday luncheon, **Kevin Stocks** will deliver his Presidential Address. Kevin is KPMG Professor and Director of the School of Accountancy at Brigham Young University's Marriott School. He has previously served as the AAA's Vice-President for Education and President of the Teaching, Learning, and Curriculum Section.

He has contributed much to the advancement of accounting education through his many service and scholarly activities.

As you might imagine, it takes at least a village to put together a meeting on the scale of our annual gatherings. This year's Program Chair is Ajay Adhikari (American University). Helping him is Lynn Rees (Texas A&M University) as Program Chair-elect. There are three separate Program Advisory committees. The Strategic

Relationships Team is being led by Ira Solomon (University of Illinois) and Bob Colson (Grant Thornton). Susan Crosson (Santa Fe Community College) is heading the Teaching and Learning Events Team and Venky Nagar (University of Michigan) is leading the Research Events Team. These individuals and their committees are assisted by many others, including the AAA's outstanding meeting planners and the staff in Sarasota. Additionally, the Section Liaisons play a major role in shaping the program. We also appreciate the work of the many, many reviewers whose work improves the quality of the meeting and provides valuable feedback to authors.

San Francisco is indeed an exciting venue. Many of you will have a familiar feel when you come to the meeting as we are going to be at the same hotels we last visited in 2005. The Hilton has done some remodeling in the interim, but it retains its extensive meeting space and is, of course, located centrally so that you and your accompanying guests can simply walk out the front door and visit many of the area's attractions.

Our AAA meetings have grown in size and diversity of program offerings so that there is always something for everyone. The Annual Meeting is like no other in its breadth of research and educational sessions, opportunities to meet and network with colleagues, career placement and supportive services, and exhibitions. And if you find yourself with a moment to spare, you can always get some exercise walking the hills of San Francisco, and perhaps snacking on some sourdough bread or Ghirardelli chocolates. Annual Meeting Highlights

CTLA, Plenary Sessions, Luncheons, Receptions, Concurrent Sessions, and Paper Dialogue Sessions

San Francisco beckons. While we are still months away from the Annual Meeting, the blueprint for an exciting program is already in place. Premeeting activities have become a highlight of the Annual Meeting and this year is no different.

On Saturday and Sunday for the third year in a row, the **Conference on Teaching and Learning in Accounting** (CTLA) will again provide an excellent resource for faculty to share and develop their teaching skills, while earning up to 16 CPE credits. CTLA is truly a great event for new and experienced faculty alike.



Also beginning Saturday you will have the option of selecting from a wide variety of **CPE Sessions** providing an opportunity to gain up to 15 CPE credits in addition to the 25+ credits you can earn at the Annual Meeting. We will kick off the Annual Meeting on Sunday in the Exhibit Hall with the Early Bird Reception offering refreshments and an opportunity to enjoy the company of our larger community.

Plenary sessions of the American Accounting Association's Annual Meeting will be held on the mornings of Monday, Tuesday, and Wednesday, August 2-4, 2010, and at lunch on Tuesday and Wednesday. This year's plenary sessions feature a comprehensive and notable group of speakers dealing with the areas of international standard setting, aligning research and scholarship to support professional practice in a global economy, role of uncertainty and risk in accounting, and other issues.

Receptions, luncheons, and breaks offer opportunities for networking with colleagues and catching up with colleagues. Sunday night will be the Early Bird Reception where you can meet our exhibitors and review their new products. Monday night features the Welcome Reception with the opportunity to socialize and connect with acquaintances and meet new friends. 
Throughout the meeting, there will be more than 350 sessions, with something for everyone. Topics covered in the concurrent sessions represent the varied interests of our membership and showcase our global thought leadership in research, education, and service. Paper and panel presentations are planned across virtually all areas of accounting coordinated by our Research Events Team, Strategic Relationships Team, Teaching, Learning Events Team, History Liaison, and the leadership of our 16 AAA sections. Scores of papers, panels, and poster sessions, including topics on teaching methodology, content and approaches, will be shared. Paper and panel topics address IFRS, sustainability, corporate governance, fair value, risk management, professional updates, and many more.

Monday's plenary speaker, Robert **Bunting**, President of the International Federation of Accountants (IFAC) will open the Annual Meeting with a presentation on how accounting education and research can advance the accounting profession as it meets the many challenges of a global economy. Bob is a Partner at Moss Adams LLP where he served as Chairman and Chief Executive Officer from 1982 to 2004. From 2004 to 2005, Bob was Chairman of the Board of Directors of the American Institute of Certified Public Accountants (AICPA). He has also served on or chaired several AICPA committees including the Audit Committee, Board of Examiners, and SEC Practice Section Executive Committee. In 2005, he

was appointed to the IFAC Board becoming Deputy President in 2006 and President in 2008.

Tuesday's morning plenary speaker features James Kroeker, Chief Accountant of the Securities and Exchange Commission (SEC). Prior to his appointment as Chief Accountant in August 2009, Jim served as Deputy Chief Accountant from 2007-2009 and Acting Chief Accountant from January 2009. Before coming to the SEC, Jim was a partner with Deloitte and Touche LLP in their National Office Accounting Services Group, Jim also served as a Practice Fellow at the Financial Accounting Standards Board where he assisted in the development of accounting guidance related to evolving accounting issues. With the SEC in the midst of many important initiatives, including the proposed roadmap for adoption of International Financial Reporting Standards in the US, Jim's remarks will be of particular interest to all members of the accounting academy.

Tuesday's luncheon speaker is Betsy Rafael, the Vice President Corporate Controller and Principal Accounting Officer at Apple, Inc. She has more than 25 years of finance and operations experience at Silicon Valley high-tech companies including Cisco, Sun, Aspect, and SGI with more than 10 years as a Senior Executive. At Apple she is responsible for global accounting activities as well

as SEC reporting and compliance requirements. Her team is also responsible for providing financial support to organizations within Apple. She is also leading a Finance Transformation effort to drive future scalability requirements.

Wednesday's plenary speaker is Robert Kaplan, Presidential Scholar and Baker Foundation Professor at the Harvard Business School. A co-developer of both activitybased costing and the balanced scorecard, Bob's research, teaching, and consulting focuses on linking cost and performance management systems to strategy implementation and operational excellence. Bob has published numerous scholarly articles and 14 books including The Balanced Scorecard: Translating Strategy into Action, winner of the AAA Wildman Medal, and Relevance Lost: The Rise and Fall of Management Accounting, recipient of the AAA Seminal Contributions to Literature Award. Elected to the Accounting Hall of Fame in 2006, Bob has been recognized by both academic and practitioner organizations worldwide for his influential contributions to global thought leadership in accounting. Bob's presentation will address the pressing need for accounting scholars

to integrate the measurement of uncertainty in fair value accounting and risk management. Bob will also participate in a panel discussion exploring his views following the plenary.

Wednesday's luncheon speaker is Kevin Stocks, KPMG Professor and Director of the School of Accountancy at Brigham Young University and the incoming President of the American Accounting Association. Kevin has served as President of the Federation of the Schools of Accountancy, as Vice President of Education for the AAA, and President of the Teaching, Learning and Curriculum Section. Through his many scholarly activities and service, Kevin has contributed greatly to the advancement of accounting education. He is also active in professional accounting organizations, including service as chair of the AICPA CPA Exam Task Force and as a member of the AICPA Education Executive Committee. In his Presidential address, Kevin will speak on the current and future challenges facing accounting education.

We look forward to a very informative and exciting Annual Meeting. Join us in San Francisco this summer.

Traditional and Paper Dialogue Concurrent Sessions

Concurrent sessions will be available throughout the day on Monday, Tuesday, and Wednesday, August 2-4. These sessions will include a wide variety of panel discussions and paper presentations - more than 350 sessions in all!

In addition to the traditional paper presentation format (i.e., three papers with a discussant), the 2010 Annual Meeting will once again offer a limited number of "paper dialogue" sessions.

Introduced at last year's Annual Meeting, the Paper Dialogue sessions provide a new presentation format for research papers. These concurrent sessions are designed for authors to gain broad feedback and to generate audience participation in a workshop-style format. Four or five papers will be grouped together for a single session, in which each presenter will have five to ten minutes to present their paper. Following the presentation, five to ten minutes will be allocated for session attendees to provide input. Then the next paper will be presented. Formal discussants will not be assigned in these paper dialogue sessions – this allows maximum time for audience participation.
