

# 2013 AAA Annual Meeting, August 3-7, Anaheim, CA Welcome from the President

Welcome to the AAA 2013 Annual Meeting. The theme of "Brilliantly Disguised Opportunities" has helped us plan an interesting and informative program. In particular, three plenary sessions will provide an overview of the meeting theme.

**Monday plenary on the future of higher education:** How will the model for the educational experience of 2023 be different from today? Can the current financial model be replaced with a model that provides high-



quality education at a lower cost or with a higher return on investment when costs are not lower? What will student

learning experiences be like in 2023? What will faculty roles and work be like in 2023? Our featured speaker will be **Jeffrey Selingo,** a journalist who has spent his career covering higher education and currently serves as editor-at-large of the *Chronicle of Higher Education* and a fellow at Education Sector, an independent think tank in Washington, DC. Jeff is also the author of *College (Un)Bound: The Future of Higher Education and What It Means for Students.* 

**Tuesday plenary on the future of academic research:** How will research be created and shared in 2023? What will the journal of the future be like? How will open access change the financial model for research dissemination? What will we use as quality metrics? How will the research career of an entry-level academic in 2023 be different from today? Our featured speakers for this session will be **Gregg Gordon,** President and CEO of the Social Science Research Network (SSRN), ranked first among the world's open access repositories of research; **Judy Luther,** 

President of Informed Strategies and past president of the Society of Scholarly Publishers; and our **2013 Presidential** Scholar, Michael Jensen. Mike Jensen's path-breaking work in financial economics has strongly influenced research on many topics, including the capital asset pricing model, stockoptions policy, and corporate governance. Mike is also known for his vision concerning academic discourse and the ways research is disseminated; he cofounded the Financial Economics Network that later evolved into SSRN.

Wednesday plenary on the future of accounting teaching and learning: What impact will developments such as MOOCs, flipped classrooms, advances in competency assessment, and advances in academic fraud prevention and detection have on accounting educators? What will the teacher of 2023 be teaching in on-campus programs? What will their students be like? How will the teaching career of an entry-level academic in 2023 be different from today? Our featured speakers for this session are **Adrian** 



Sannier, Senior Vice President for Product at Pearson, formerly professor of Interdisciplinary Engineering, University Technology Officer, and professor of Computing Studies, and one of the "12 Tech Innovators Who Are Transforming






