President's Invitation to Anaheim

I am very pleased to invite you to the 2008 American Accounting Association's Annual Meeting in Anaheim, California. The Meeting will begin on Sunday, August 3 and end Wednesday, August 6. The Theme for this year's meeting is "Building Our Accounting Community," which features the view that our Community is "inclusive" and dynamic. Everyone who becomes a member becomes a part of the accounting education community, regardless of whether we teach and research or practice in financial accounting, managerial, taxation, auditing, governmental, systems, or are focused on the public interest, gender issues, or accounting history. The centerpiece of the meeting is a series of three plenary sessions on Monday, Tuesday, and Wednesday mornings.

Well-known, independent scholar John Steele Gordon will speak on "Accounting: A Force for Progress over the Centuries." Gordon, a specialist in business and financial history, publishes regularly in Forbes, Worth, The New York Times, Barron's, The Wall

Street Journal, the Washington Post's Book World and Outlook. He is a contributing editor at American Heritage, where he has written the "Business of America" column since 1989.

On Tuesday morning,
Presidential Scholar, Professor
Zoe-Vonna Palmrose, will speak
on "Science, Politics, the Media,
and Accounting: Perspectives
from the Potomac." Professor
Palmrose is now serving as
Deputy Chief Accountant for
Professional Practice in the
Office of the Chief Accountant

at the SEC, while on leave from the University of Southern California. She has published and spoken extensively on a variety of issues related to the quality of financial reporting and auditing. She is coauthor of *Thog's Guide to Quantum Economics: 50,000 Years of Accounting Basics for the Future.*

Tuesday's Luncheon Speaker, Aulana Peters, will address "Globalization: Implications for Accounting and Accounting Education." Ms. Peters, a former partner of the law firm of Gibson, Dunn & Crutcher, also has served as a member of the U. S. Securities and Exchange Commission. Currently Peters serves on the U.S. Comptroller General's Accountability Advisory Council and the International Public Interest Oversight Board. She is a director of 3M Corporation, Merrill Lynch & Co., Inc. and Deere & Company.

John Biggs will conclude the plenary speaker series and will focus on: "The Importance of Accounting Education in the 21st Century." Dr. Biggs, is Chairman Emeritus of Teachers Insurance and Annuity Association-College Retirement Equities Fund (TIAA-CREF), and a Director of the Boeing Company where he chairs the audit committee of the Board. He is a Trustee of

Washington University, The Danforth Foundation in St. Louis and The Santa Fe Opera and serves as Chairman of the Board for Emeriti (a non-profit company offering post-retirement medical benefits to college faculty). He has published a number of papers on corporate governance, variable annuities, social security, regulation and taxation of pension plans, and demographic effects on pensions.

The leaders of the AAA have worked hard with the representatives and co-chairs of the Program Advisory Committee, Tonya and Dale Flesher, of the University of Mississippi, to make optimal use of available space and meeting times during the days of our gathering by assembling a program to benefit all of our members and serve as a resource to bolster our community's intellectual capital. I encourage you to plan on staying for the entire meeting to avoid missing any of the many events right through the conclusion of our meetings on Wednesday afternoon. The

convention hotel rates are attractive, so please make your plans early.

The meeting will be an inclusive gathering where you will be able to network effectively and identify issues and research topics that will serve your own broad spectrum of interests. Because of Anaheim's proximity to Pacific Rim countries, there will be even greater opportunities to network with members from this region, where a large number of our overseas members reside.

Annual Meeting Highlights

Plenary Sessions, Mini-Plenary Sessions, Luncheons, Receptions, and Awards

Plenary sessions of the American Accounting Association's Annual Meeting will be held from 8:30 to 9:45 AM on Monday, Tuesday, and Wednesday, August 4-6, 2008. Speakers are scheduled for the Tuesday and Wednesday luncheons. This year's plenary sessions feature a wide-ranging and impressive group of speakers dealing with the areas of business history, global issues affecting the profession, governance, and the SEC. Receptions, luncheons, and breaks offer opportunities for networking with colleagues and catching up with friends. During the evening of Sunday, August 3, the Exhibit Hall will host the informal Early Bird Reception and a chance to check out the exhibits. Also on Sunday evening the Second Annual Career Fair will be held near the Exhibit Hall. Monday night, August 4, is the Welcome Reception that includes food and beverages, and an opportunity to enjoy the gathering of our larger community. On Tuesday night, August 5, we will celebrate with a themed reception, featuring food and beverages to befit the meeting location.

In addition to the plenary sessions, there will be something new this year: Mini-Plenary sessions. The new Mini-Plenary sessions will be concurrent

sessions, but will be in rooms large enough to accommodate up to 25% of those in attendance. Research submissions this year were up 25% over last year, meaning that this year's program will be the largest in history. Throughout the meeting, there will be over 300 concurrent sessions, so there will be something for everyone at this meeting. For those who are interested in international accounting, there will be plenty to keep you busy as over half of the research submissions this year came from outside of the United States. Apparently the site near Disneyland and the buying power of foreign currencies has made this year's meeting especially attractive to our international members.

And, it's not all research. The AAA is composed primarily of teachers, so there will be dozens, if not hundreds, of papers and poster sessions on teaching methodology and techniques. One of these will be a Mini-Plenary by former president **Stephen Zeff** (Rice University) and **Paul Pacter** (Deloitte Hong Kong) on how to incorporate IFRS into your classes.

Monday, August 4

Monday's plenary speaker will address the historical links between accounting and other areas of business and economics. Noted business historian John Steele Gordon will open the annual meeting with a session entitled "Accounting: A Force for Progress Over the Centuries. Gordon has published in a variety of outlets, including Forbes, The New York Times, Barron's, The Wall Street Journal, and the Washington Post. He has been a contributing editor of American Heritage, where he has authored the "Business of America" column since 1989. The plenary session will be followed by lunches and meetings for members of various special interest sections. There will also be over 100 concurrent sessions during the day, which will include the presentation of over 300 research papers and teaching suggestions. A Mini-Plenary will involve a panel session

featuring the accounting Profession's so-called "Summit Group," which consists of the staff leaders of all of the professional accounting organizations in the United States. That Summit session



will be followed by smaller concurrent sessions that will give attendees an opportunity to have conversations with one or more of the Summit panel participants, such as **Barry Melancon** of the AICPA. Another major session will feature **James Hasselback** (University of West Florida) who will be speaking on the demographics of the accounting professoriate.

Tuesday, August 5

The Tuesday plenary session will feature one of our own members, Professor **Zoe-Vonna Palmrose**, who will speak on "Science, Politics, the Media, and Accounting: Perspectives from the Potomac." Professor Palmrose is currently on leave from the University of Southern California while she serves as the Deputy Chief Accountant for Professional Practice at the Securities



and Exchange Commission. Tuesday's luncheon speaker will be Aulana Peters, a former commissioner of the Securities and Exchange Commission, who will speak on Globalization: Implications for Accounting and Accounting Education. Ms. Peters currently serves on the U.S. Comptroller General's Accountability Advisory Council and the International Public Interest Oversight Board. She is a director of 3M Corporation, Merrill Lynch & Co., Inc., and Deere & Company. In the afternoon, there will be a Mini-Plenary session on the subject of Private Company Financial Reporting, with AICPA leaders James Castellano and Judy O'Dell heading the panel, along with Rick Elam (University of Mississippi). There will also be 130 concurrent sessions during the day Tuesday, with papers on almost every conceivable topic in the field of accounting and/or accounting education. Those with an interest in governmental accounting can look forward to a special panel session, led by Relmond Van Daniker, on the topic of Citizen Centric Reports. Recent activity among regulatory agencies will be addressed in panel sessions on COSO activities, the Treasury Advisory Committee on the Auditing Profession, and the SEC Advisory Committee on Financial Reporting (the Pozen Committee).



Wednesday, August 6

John Biggs, the chairman emeritus of Teachers Insurance and Annuity Association-College Retirement Equities Fund (TIAA-CREF), will lead off the



Wednesday program with a presentation entitled "The Importance of Accounting Education in the 21st Century." Biggs is a director of Boeing Corporation and chairs the audit committee of the board. Over the years, Dr. Biggs has published a number of papers on corporate governance, variable annuities, social security, regulation and taxation of pension plans, and the effects of demographics on pensions. The plenary session will be followed by two sessions on personal financial planning. Given the demographics of the accounting professoriate, we thought it would be appropriate to have a session on retirement planning (over half of American accounting professors are over the age of 55). Thus, TIAA-CREF has volunteered to put on a program entitled "Retirement Planning for Those 55 and Over." The younger half of the professoriate is not being ignored; there will be a separate session entitled "Retirement Planning for Those Under 55."

During the Wednesday luncheon, incoming AAA President for 2008-2009, Susan F. Haka, will address our changing member profile, including the increase in international members, all of which affect what we do as a discipline and as a profession to serve the needs of students and more broadly, the needs of society. Sue Haka is the Ernst & Young Professor of Accounting at Michigan State University. Other events on Wednesday will include a major panel session on XBRL, and another on the views of two special committees on Research Impact. Wednesday afternoon will feature a presentation by the winner of the AAA Teaching Innovations Award. There will also be a presentation on the AAA's Global Digital Archive Network. Accreditation issues will also be addressed in a number of sessions. There will be a couple of sessions on recent FASB activities, including a panel discussion of the proposed change to reduce the size of the FASB, and another on the New Financial Reporting Model. Still another session, led by Peter Wolnizer of the University of Sydney, will address "How to Write and Publish an Accounting Book." ■




