Dear Current, and Future, Members of the International Accounting Section,

I will focus the majority of this letter on professional matters related to the section. However, I want to first send condolences, on behalf of the International Accounting Section, to all who have suffered personal loss during the last year and a half. The generosity of our members, the donation of their service and energy to the section, and the efforts to support each other provides the foundation of our section. Losses to any of the members of the Section are losses to us all. However, as we continue through these difficult times, I am confident that foundation will provide the Section the strength to support its members and to provide valuable resources and opportunities for Section members to advance their research, teaching and practice activities.

#### 2020-2021 Activities

The commitment, energy, and creativity of our section members are reflected by the Section's excellent accomplishments over the last year. First, despite an extensive period of uncertainty regarding the format of the 2020 IAS Midyear Meeting, and the eventual need to convert to a virtual format, Co-Chairs Hong Kim Duong and Sydney Shu, with the support of Judy Beckman, coordinated a very successful meeting, including a productive PhD Student/New Faculty Consortium coordinated by Maria Vulcheva. A notable feature of the meeting was Kim's and Sydney's leveraging of the virtual format to schedule sections outside of the traditional 8am to 5pm local time format, enabling participants all over the world to present papers and attend sessions that were sensitive to their time zones.

A very successful eighth annual *JIAR* Conference was also held virtually in June 2021. The conference was packed with two days of incredible sessions including over 80 paper presentations, multiple insightful panels, and keynote speaker Charles Lee. And, again, the conference leveraged the virtual format to provide a more inviting conference to attendees worldwide, with sessions ranging from 8am EDT to after 9pm EDT over two days. Congratulations to Agnes Cheng, *JIAR* Conference Planning Committee Chair, Stephen Lin, *JIAR* Editor, and the *JIAR* Conference Planning Committee Members: Greg Burton, Betsy

Gordon, Samir Trabelski, and Joanna Ho for a successful conference. A special thanks goes out to the University of Memphis Crews School of Accountancy for sponsoring the Conference.

The 2020-2021 year also saw the introduction of the International Accounting Section Webinar series which provided section members an opportunity to participate in research seminars focused on international accounting research despite the inability to travel. Thanks go out to Cristina Florio and Minna Yu, Co-Chairs of the Section's International Relations Committee for their investments in the webinar series, and to Helen Kang for hosting the webinars scheduled at times more appropriate for our members in Asia, Australia, and New Zealand.

At this year's AAA Annual Meeting, IAS Annual Program Co-Chairs John Wang and Brigitte Muelmann organized a strong program on behalf of the Section. The program included six excellent panels covering research, teaching, and practice issues, and seven concurrent sessions including 28 research paper presentations. A special thanks goes out to the 86 section members who volunteered to serve as reviewers, discussants, and moderators. During the Annual Meeting, Section award winners were announced at the Section's business meeting. Please join me in congratulating the following winners.

In addition, with a very short timeline, the Section prepared a formal response voicing section members' concerns regarding the "Model Curriculum" unveiled by the AICPA and NASBA in June of 2021. A non-exhaustive list of the concerns voiced in that letter includes: the inappropriateness of outside organizations developing curricula in lieu of faculty and universities, the lack of discussion of critical thinking skills, the lack of inclusion of alternative accounting frameworks such as IFRS, and no reference to a conceptual framework. Thanks go to Judy Beckman, Gia Chevis, Giorgio Gotti, Elaine Henry, Gerlando Lima, Asheq Rahman, and Laura Swenson for their contributions to this response.

The International Accounting Section's program was sponsored by the International Accounting Association and organized by the co-chairs, Brigitte Muehlmann (Babson College) and John Wang (University of Cincinnati). There were 7 concurrent sessions with 28 paper presentations and 6 panel discussions, covering topics such as sustainability (ESG) reporting and assurance, the implication of XBRL in research and teaching, editors' and researchers' perspectives on the directions of international accounting research, international accounting curriculum, and the influences of users on the financial reporting system. There were 86 reviewers, 61 discussants, 27 moderators, and about 450 attendees in the concurrent sessions and panel discussions of the International Accounting Section at the virtual annual meeting.

#### 1. Call to Order – Judy Beckman

Judy Beckman started at 7:02pm and thanked all for attending the meeting. She acknowledged that there was uncertainty regarding whether the meeting was going to be virtual/face-to-face. She commented on many challenges from the pandemic in the past year especially for young families and research activities, etc. She announced sad news that KK Boonlert-U-Thai's (Advisory Board Co-Chair) mother passed away very recently and expressed condolence to his family on everyone's behalf.

Judy Beckman announced that the 2022 MYM (which is scheduled to be face-to-face) will be in January 2022 in Las Vegas (more information later in the business meeting).

The 2022 JIAR Conference is scheduled to be held in Taiwan and in the UK the year after.

Judy Beckman thanked the Teaching and Curriculum Committee and Co-Chairs, Asheq Rahman and Laura Swenson, for responding to the AICPA "Model Curriculum" for the US. Gia Chevis,

Giorgio Gotti, Elaine Henry, Gerlando Lima and Judy herself had several meetings in relation to providing responses on behalf of the Section. She thanked all who were involved.

# 2. Approval of Minutes from International Accounting Section Committee Chairs Meeting held at the 2021 MYM

Judy Beckman made two announcements:

- Incoming Treasurer for the Section will be Lucy Chen who was the Co-Chair for the Annual Meeting last year (2020). She was appointed by Judy Beckman after consultation with the Advisory Board Co-Chairs and the Nominations Committee Co-Chairs. She will replace Gia Chevis who is the incoming VP-Academic. Lucy Chen has already been helping with the budget and other material for this meeting. Thank you and welcome to the role.
- Elaine Henry (incoming chair of the Nominations Committee) has already called for next year's members of the Nominations Committee to appoint a Chair of the Advisory Board. Betsy Gordon will be the next Advisory Board Chair.

# 4. Committee Reports

# (a) 2021 Annual Meeting Program – Brigitte Muehlmann and John Wang (Co-Chairs)

John Wang delivered the following report on behalf of Brigitte Muehlmann and George Wu (member).

# [from the report sent in prior to the meeting]

For the Annual Program, there are a total of 40 paper submissions and 7 panel proposals for the International Accounting Section. The number of paper submissions is significantly lower than previous years. We have 86 reviewers signed up. On the positive side, for most papers, we were able to assign two reviewers per paper. In addition, we made a great effort to match the reviewer's expertise with the paper. Though this process took more time and effort, there are several benefits from this process. The reviewers are more likely to accept the review request, provide more insightful comments and suggestions, and more likely to agree to serve as discussants. For most of the panel proposals, we assigned reviewers and received some very insightful feedback and suggestions.

To recognize reviewers who provide outstanding reviews of papers submitted to the IAS Annual Meeting Program, we continue the International Accounting Section Excellence in Reviewing Awards. Along with David Godsell (Chair of the IAS Research Committee), we are pleased to select

and announce 9 winners of the International Accounting Section Excellence in Reviewing Awards for the 2021 Annual Meeting (will be recognised in tomorrow' Business Meeting).

During the virtual meeting, the International Accounting Association will sponsor 6 panels covering research, teaching, and practices. Topics covered in the panels include sustainability (ESG) reporting and assurance, the implication of XBRL in research and teaching, editors' and researchers' perspectives on the directions of international accounting research, international accounting curriculum, and the influences of users on the financial reporting system.

During the virtual meeting, the International Accounting Association will have 7 concurrent sessions with 28 papers to be presented. There are 61 discussants and 27 moderators signed up. With the help of many volunteers, we are able to assign one discussant to every paper and one moderator for each session. We were conscious of different time zones and made efforts to assign moderators and discussants to the session that is time-friendly to them.

#### Comments from Judy Beckman:

- She commented that we sponsored a pre-conference CPE session on *Sustainability Accounting Standards, Risk Management and Audited Sustainability Reporting Session* on Friday, July 30 from 1 to 5. It was an excellent session with 30 participants.
- The panellists are willing to run the session again because it was so well received, and we feel we can expect more International Section participation with better advertising.
- She encouraged everyone to participate in the global gathering organised by Giorgio (also the Panel Session on Wednesday morning – on national accounting organisations). Look for 'All Sessions – Global Gathering 8:45am.

#### (b) Outstanding Dissertation Committee – Elizabeth Gordon (NA) Nothing Noted.

#### (c) Outstanding Educator Committee – Wayne Thomas

Wayne Thomas reported on behalf of the Committee (Charles Stanley, Mahmud Hossain, Peter Aghimien). Advertised for the award and ended up with a unanimous selection of the recipient of the award. All committee members were very helpful and worked well.

Comment from Judy Beckman:

• A short 2-minute speech from each recipient of awards at the Business Meeting was suggested and all recipients were notified to do so.

# (d) Outstanding Service Award Committee – Giorgio Gotti

Giorgio Gotti reported on behalf of the Committee comprising Paul Munter, Elaine Henry, Lucy Chen, Terri Conover. We have a very worthy recipient. To be announced at the Business Meeting tomorrow.

## (e) PhD Student Travel Grant Committee – Tami Dinh (NA)

On behalf of the Chair, Judy Beckman noted that there is a worthy recipient for the Travel Grant, and she will announce the winner tomorrow at the Business Meeting.

#### [from the report sent in prior to the meeting]

There were several rounds of promoting the PhD grant. Finally, by 15 March 2021 only one application was received. Given the virtual setting, the travel reimbursement was replaced by a grant for covering the costs of the registration fee as well as the IAS member section fee. All committee members confirmed that the application by Luke Phelps from Queen's University was of high quality and he should be awarded the grant. The name has been forwarded to the AAA Annual Meeting coordinators so he can be assigned being a discussant. Hopefully once the meeting is back in-person, the grant will also become more attractive. Given the financial constrains many universities are currently facing, the support should be highly valued.

# (f) JIAR Conference – Agnes Cheng and Steve Lin

Agnes Cheng and Steve Lin reported that the JIAR best paper award is determined by the Publications Committee but will be announced by the JIAR Editor. Unfortunately, three recipients of the award will not be attending the Business Meeting tomorrow.

To be announced at the Business Meeting tomorrow by Steve Lin who will also announce the JIAR best reviewers.

# (g) Publications Committee – Agnes Cheng

Agnes Cheng reported that the JIAR papers for consideration were all very good and the decision for the best JIAR paper was a unanimous decision.

# (h) Advisory Board – Co-Chairs Kriengkrai Boonlert-U-Thai and Stephen Salter

On behalf of the Co-Chairs, Judy Beckman reported that the Co-Chairs discussed with her in relation to having non-US members being part of the Section leadership. One suggestion was that the Nominations Committee should be encouraged to consider for the Executive Committee or Advisory Board acceptable non-US candidates. This involves changes to the Operating Manual which was voted on and approved by the Executive Committee at the meeting today.

# (i) Nominations Committee – Steve Lin (current chair of Nominations Committee) Elaine Henry (incoming chair of Nominations Committee))

Elaine Henry asked everyone to keep an eye on any call for nominations for upcoming positions. The announcements are usually in October.

#### (j) Communications Director – Ya-wen Yang

• Ya-wen reported that it is still a one-person Committee for two years in a row. However, Weishi Jia is an incoming as Co-Director and they will serve together in the coming year.

Coordinated with the AAA staff members to make meetings and awards information as well as the international accounting course syllabi collected by the Teaching and Curriculum Committee available on the section website. In addition:

- Updated website information
- Prepared two Section newsletters in September 2020 and February 2021 (Issue No. 117 and No. 118).
- AAA not yet updated the websites
- After the Annual Meeting, there will be another newsletter

#### (k) Research Committee – David Godsell

David Godsell reported on behalf of the Research Committee:

- Reviewed nominations for best paper and reviewer awards and recommended award recipients to Mid-Year Meeting and Annual Meeting conference organizers.
- Even though the number of submissions were down for the meeting, quality of the best paper nominees was very high. There were three outstanding paper awards
- Marked improvements in reviews year over year potentially due to offering more awards for best review.
- Organized AAA Annual Meeting Panel, "International research: raison d'etre" on why international accounting exists (Panellists: Helena Isidro, Ole-Kristian Hope, Ken Klassen, Grace Pownall, Roger Silvers).
- Increasing prominence in journals number of international accounting papers being published in top six journals has been increasing over time (especially during the last six years)

David Godsell will continue to be the Chair for the Research Committee. There is now a two-page mandate for the Committee. New members will be:

- David Godsell, University of Illinois at Urbana-Champaign
- Feng Chen, University of Toronto
- Jing Huang, Virginia Tech
- Luke Phelps, Queen's University
- VP academic to serve on the RC

Judy Beckman reported that David Godsell proposed that, for greater connection between the Executive Committee and the Research Committee, the VP-Academic should be to part of the Research Committee. This will assist the Committee and the incoming President to undertake longer time horizon initiatives. The recommendation was passed by the Executive Committee today.

#### (I) Teaching and Curriculum – Asheq Rahman and Laura Swenson

Judy Beckman thanked Laura Swenson and Asheq Rahman for their assistance in preparing the responses to the AICPA's "Model Curriculum".

Asheq Raman reported that:

- They were part of the responses to the AICPA "Model Curriculum" and the AACSB-sponsored initiative, Management Curriculum for the Digital Era (MaCuDE).
- Changes to the US can impact outside the US and can be helpful or can come back to haunt us.
- All members of the ad hoc committee attended the June conference sponsored by AAA, AICPA, and NASBA and identified concerns about the "Model Curriculum" in relation to:
  - Critical thinking
  - Data analytics
  - International settings providing interesting context for students to better develop critical thinking skills
- There will be a Panel Session on International Accounting in the Curriculum at 3:30pm on Wednesday 4<sup>th</sup> August
- Depository for syllabi still open at the website below
- All accredited schools have been contacted and syllabi can be found at:

- The Committee will continue to update this repository with new submissions of syllabi.

Laura Swenson encouraged everyone to attend the Panel Session on Wednesday 4<sup>th</sup> August. The Panel will comprise Abbie Daly (University of Wisconsin–Whitewater), Cynthia Jeffrey (Iowa State University), Robert Knechel (University of Florida), Muhammad Nurunnabi (Prince Sultan University) and Asheq Rahman (Auckland University of Technology).

Laura Swenson noted that Asheq Rahman is stepping down as Co-Chair. She also thanked Judy Beckman for her assistance in preparing the response letter to the AICPA.

Judy Beckman commented that there was a workshop organised by the AAA on 15<sup>th</sup> June on the matter. Members of the committee stepped up to work on the responses and the responses were sent on 26<sup>th</sup> July. The letter will be posted on the International Section web page.

- The group comprised Judy Beckman (Chair), Gia Chevis, Giorgio Gotti, Elaine Henry, Gerlando Lima, Asheq Rahman, and Laura Swenson. Bowe Hansen also participated in some meetings and provided feedback.
- Concerns raised in the responses letter:
  - Professional organisations rather than academics recommending what happens at universities
  - No critical thinking
  - No inclusion of IFRS (alternative accounting framework)
  - No conceptual framework
  - IFRS excluded from CPA exams while this is a separate issue decided apart from the CPA evolution initiative, nonetheless the committee sees this exclusion as integral to other concerns.

 At Elaine Henry's suggestion, the group also provided input on the AICPA model curriculum to the AACSB-sponsored initiative Management Curriculum for the Digital Era (MaCuDE) (<u>https://macude.org/</u>).

#### (m) Practice Issues – Tom Young (NA)

On behalf of the Chair, Judy Beckman reported that Tom Young was involved in developing a Panel Session with KPMG on Sustainability Reporting (with Brigitte Muehlmann) on Thursday).

#### (n) Membership Committee –Stephani Mason (NA)

On behalf of the Chair, Judy Beckman reported that there has been loss of membership at AAA overall. We have been working hard with the AAA to try to stem the loss of membership.

Bowe Hansen commented that, from the budgetary perspective, we should continue to get as many people as we can get to join the Section and then get involved in the Section. Potentially, we could recruit them to be part of the Committees.

Agnes Cheng commented that there are more country representatives attending this Committee Chair Meeting.

• This year, Giorgio was part of the Global Initiatives. Given that regional representatives (Country Liaison Officers) stay longer in their positions, perhaps we can get some of them to represent the Section as international representatives at the Global Initiatives.

Judy Beckman commented that the webpage for the Global Initiatives is coming. Country Liaisons can definitely contribute to this (Cristina Florio and Minna Yu can potentially work with Giorgio?).
