Mark C. Dawkins, Ph.D., MBA, MACC, CPA, CMA, CGMA, served as Dean and Distinguished Professor for Excellence in the Coggin College of Business (Coggin) at the University of North Florida (UNF) from June 2015-June 2020. Prior to this appointment, he was Associate Professor of Accounting in the Terry College of Business at the University of Georgia (UGA). At the Terry College, he served as Associate Dean for Academic Programs from 2008-2014, Director of Diversity Relations from 2004-2008, and as an accounting faculty member from 1994-2015. He received his Ph.D. in Accounting from Florida State University, MBA (finance), and MACC (auditing) degrees from the University of Florida, and a BS in Management from the Georgia Institute of Technology.

As Coggin Dean, he works closely with other deans, vice-presidents, and administrators, four department chairs (Accounting & Finance, Economics & Geography, Management, and Marketing & Logistics), two flagship program directors (International Business and Transportation & Logistics), and directors of the Small Business Development Center, Career Management Center, Academic Advising Services, and Development. As the Associate Dean for Academic Programs at UGA, his responsibilities included oversight for eight of Terry's nine undergraduate degree programs, as well as five master's programs (MBA, MACC, MMR, MIT, and MA-Econ). The department heads of Terry's seven academic departments reported to the Associate Dean's office. Additionally, the directors of the MBA Programs, the Music Business Certificate Program, and the Institute for Leadership Advancement reported to the Associate Dean's office, as did Terry's Director of Diversity Relations and Director of Assessment, Rankings, and Undergraduate Programs.

As a faculty member, he has published in Journal of Finance, Journal of Financial & Quantitative Analysis, Journal of Accounting, Auditing and Finance, Journal of Business, Finance & Accounting, Journal of Banking and Finance, Advances in Accounting, Issues in Accounting Education, Accounting Perspectives, Academy of Educational Leadership Journal, Management Accounting Quarterly, Journal of Managerial Issues, The CPA Journal, and other peer-reviewed journals. He has taught undergraduate and graduate financial accounting classes, specifically Intermediate Accounting 1, Advanced Accounting Theory (graduate), MBA Financial Accounting, and Intermediate Accounting for Non-Majors. He also taught the undergraduate and graduate accounting internship classes during his six years as Associate Dean in the Terry College of Business.

He was a co-recipient of the 2006 and 2003 Beta Alpha Psi Outstanding Teacher of the Year award at UGA and also received the 2006 and 2003 Alpha Kappa Psi Accounting Teacher of the Year Award. He is a member of the American Accounting Association (AAA), the American Institute of Certified Public Accountants, the Institute of Management Accountants, the Florida Society of CPAs, PhD Project (www.phdproject.org), and the Accounting Doctoral Student Association. In August 2009, he was one of five recipients of the inaugural Ernst & Young *Inclusive Excellence Award for Accounting and Business School Faculty*. In January of 2014, he received the 2014 UGA President's Fulfilling the Dream Award at the MLK Freedom Breakfast at UGA. In 2016, 2013 and 2007, he received the AAA Diversity Section Service Award, and he is the only multi-year recipient.
