## Joseph F. Brazel, Tina D. Carpenter, and J. Gregory Jenkins receive the AAA/Deloitte Foundation 2014 Wildman Medal Award

**Sarasota, FL, August 15, 2014** - The American Accounting Association (AAA) would like to congratulate Joseph F. Brazel, Tina D. Carpenter and J. Gregory Jenkins as recipients of the 2014 AAA/Deloitte Foundation 2014 Wildman Medal Award for their paper, "Auditors' Use of Brainstorming in the Consideration of Fraud: Reports from the Field" published in the July 2010 issue of The Accounting Review. This AAA award, which is sponsored by the Deloitte Foundation, was presented to each recipient in the form of a medal and monetary prize on Wednesday, August 6th at the 2014 AAA Annual Meeting held in Atlanta, Georgia.



**Joseph F. Brazel** is a Professor of Accounting at North Carolina State University where he is the Reznick Group Research Fellow and a University Faculty Scholar. His research focuses on

fraud detection, professional skepticism, nonfinancial measures, investor use of fraud red flags, fraud brainstorming, and judgment and decision-making in auditing. He has published in *The Accounting Review*, the *Journal of Accounting Research*, and *Contemporary Accounting Research*. The FINRA Investor Education Foundation, the Institute of Management Accountants, the Institute of Internal Auditors, the Institute for Fraud Prevention, Ernst and Young, KMPG, the International Association for Accounting Education and Research, and North Carolina State University have all supplied him with grants to support his research. He has served on the AAA's Notable Contributions to the Accounting Literature Award Selection Committee, Competitive Manuscript Award Committee, and COSO Task Force. Prior to obtaining his Ph.D., he was an audit manager with Deloitte.

Tina D. Carpenter, PhD, CPA, is an Associate Professor of Accounting in the Terry College of Business at the University of Georgia. Tina's research investigates the prevention and detection of fraudulent financial reporting. She was awarded the AAA Auditing Section Outstanding Dissertation Award for her dissertation on fraud brainstorming. Three of her other papers have been awarded the AAA ABO Section Outstanding Manuscript. Tina was recently selected by the AAA and PCAOB to serve on a research team to synthesize fraud research. Her research contributes to theory and practice. As a result, Tina has been invited to serve on a fraud panel at the PCAOB, and her research has been cited by the PCAOB and SEC. Tina has been recognized for teaching excellence with awards at the department, college and university levels. Tina was recently interviewed by the *United States Department of Defense* for her expertise in fraud.

**J. Gregory Jenkins, CPA**, is Professor of Accounting & Information Systems and holds the Curling and William S. Gay Faculty Fellowships at Virginia Tech. He has published in Accounting, Organizations and Society, Accounting Horizons, Auditing: A Journal of Practice & Theory, Behavioral Research in Accounting, Current Issues in Auditing, Journal of Accountancy, Journal of Information Systems, The Accounting Review, and The CPA Journal. Greg currently serves as the co-editor of Current Issues in Auditing, the AAA Auditing Section's online journal. His recent professional activities include serving on the AICPA's Practice Monitoring of the Future Task Force and chairing the Virginia Accounting & Auditing Conference. Greg has also served on research task forces of the AAA's Auditing Section that provided research assistance to the PCAOB related to quality control standards and auditor independence. He previously worked as an auditor with Ernst & Young and McGladrey.

The Wildman Medal Award was founded in 1978 to commemorate John Wildman and to encourage research relevant to the professional practice of accounting to which much of Mr. Wildman's life was devoted. Richardson as recipients of the 2014 *Accounting Horizons* Best Paper Award for their article, "Integrating Information Technology into Accounting Research and Practice." This AAA award was presented to Professor Geerts, Dr. Graham, Dr. Mauldin, Professor McCarthy, and Professor Richardson in the form of a unique glass art piece and a \$2,500 prize on Wednesday, August 6th at the 2014 AAA Annual Meeting held in Atlanta, Georgia.



**Guido L. Geerts** is a Professor and EY Faculty Scholar at the Lerner College of Business, University of Delaware. He earned his Ph.D. from the Free University of Brussels. He has published in a variety of accounting and information systems journals, including *Accounting Horizons, Decision Support Systems, IEEE Intelligent Systems, International Journal of Accounting Information Systems, Journal of Emerging Technologies in Accounting, and Journal of Information Systems.* He serves on several editorial boards and is currently guest editor for a special issue on Business Process Modeling (*International Journal of Accounting Information Systems*) and for a special issue on Enterprise Ontologies (*Journal of Information Systems*). Guido has twenty-seven years of teaching experience and previously taught at Michigan State University and the Free University of Brussels. He has received numerous awards for teaching and research excellence including the Lerner College Outstanding Scholar Award (2014), the Lerner College Outstanding Teacher Award (2013), and the SET Section's Outstanding Researcher Award (2010).

**Lynford E. Graham** is a CPA with more than 30 years of audit practice and policy development experience. He is a Visiting Professor of Accountancy at Bentley University in Waltham, MA. Dr. Graham is a member of the AICPA, and a past member of the Auditing Standards Board. He chaired the AICPA's *Assessing Audit Risk* Guide and the AICPA *Audit Sampling* Guide Task Forces. He was a Partner and the National Director of Audit Policy for BDO, LLP. Prior to that, Dr. Graham was an Associate Professor at Rutgers University. Before Rutgers, he was a National Accounting & SEC Consulting Partner at Coopers & Lybrand, responsible for technical issues research, auditing research and sampling. A Certified Fraud Examiner, in 2002 he received the Distinguished Service Award from the Auditing Section of the AAA. Dr. Graham holds an MBA and Ph.D. from the University of Pennsylvania, (Wharton School). He is editor of *The Accountant's Handbook* – 12th Edition (Wiley, 2012).

**Elaine G. Mauldin** is an Associate Professor and the BKD Professor in the Trulaske College of Business at the University of Missouri. Prior to obtaining her PhD, Elaine was V.P. Finance for a multi-state construction holding company. Professor Mauldin is a member of the American Accounting Association, American Institute of CPAs, the Institute of Internal Auditors, and the Information Systems Audit and Control Association. Elaine's primary research interests are auditing, governance and internal controls. In addition to *Accounting Horizons* she has published papers in a variety of academic journals including *Journal of Accounting & Economics, The Accounting Review, Contemporary Accounting Research,* and *Accounting Organizations & Society*. Elaine serves as an editor for *The Accounting Review* and as the AIS Section representative on the AAA Council. Elaine teaches accounting information systems, internal controls and auditing.

William E. McCarthy is a Professor of Accounting and Information Systems at Michigan State University. He teaches classes in enterprise information systems, object-oriented analysis and programming, advanced database design, and accounting interoperability. His research has been supported by multiple accounting and technology firms and by the National Science Foundation. During the 1980s, Professor McCarthy worked in the Artificial Intelligence Group of Accenture where he was part of a research team that analyzed the first uses of embedded semantics for the SEC's EDGAR system, and most recently, he has been especially active in international ecommerce standardization efforts with the United Nations and ISO. In 1999, Professor McCarthy was given the "Withrow Teacher-Scholar Award," the lifetime teaching award from the Broad College of Business, and in 2000, he was presented with the "Michigan State University Distinguished Faculty Award." In 2008, he was given the AAA "Outstanding Accounting Educator Award."

**Vernon J. Richardson** is the S. Robson Walton Chair and Distinguished Professor of Accounting at the Sam M. Walton College of Business at the University of Arkansas. He received his Ph.D. in accounting from the University of Illinois. He has served as editor of *The Accounting Review* and as associate editor of *MIS Quarterly*. He has published in *The Accounting Review*, the *Journal of Accounting and Economics, Contemporary Accounting Research, MIS Quarterly*, the *Journal of Marketing* and the *Journal of Operations Management*. His research is at the cross-section of accounting, finance and information systems and generally considers the financial antecedents and consequences of IT investments.

The Accounting Horizons Best Paper Award is presented to the best paper published each calendar year. The award winner is selected by online voting open to all Accounting Horizons subscribing members of the American Accounting Association. **Nemit Shroff** is an Assistant Professor at the MIT Sloan School of Management. His research focuses on the real effect of accounting disclosures on corporate investment and financing decisions. His work has won a number of awards including the FARS best dissertation award and the Ross School of Business Emeriti award. Further, his research been published in leading academic journals, including *Journal of Financial Economics*, *Journal of Accounting Research* and *The Accounting Review*. Professor Shroff teaches Financial Accounting to undergraduate and MBA students, and a class on the real effects of accounting to Ph.D. students. He completed his doctoral studies at University of Michigan in 2011 under the supervision of Professors Michelle Hanlon and Russell Lundholm. During his doctoral studies, he was one of ten students across the country to be awarded the Deloitte Foundation's Doctoral Fellowship and was also invited to participate in the Deloitte Doctoral Consortium at Tahoe City.

The Competitive Manuscript Award was created to encourage research among AAA regular, life, and student members who have earned their Ph.D. within the past five years. The winner is chosen annually in a blind review by the AAA Competitive Manuscript Award Committee. Christian Leuz, Dhananjay Nanda, and Peter D. Wysocki for their work entitled, "Earnings management and investor protection: an international comparison" This AAA award was presented to Professors Leuz, Nanda, and Wysocki in the form of unique glass art pieces and a monetary prize on Tuesday, August 5th at the 2014 AAA Annual Meeting held in Atlanta, Georgia.



Christian Leuz, Joseph Sondheimer Professor of International Economics, Finance and Accounting at the University of Chicago's Booth School of Business. He is also a Co-Director of the Initiative on Global Markets, a Research Associate at the National Bureau of Economic Research and a Fellow at the European Corporate Governance Institute, Wharton's Financial Institution Center, Goethe University's Center for Financial Studies, and in the CESifo Research Network. His research examines the role of corporate disclosures, accounting transparency and disclosure regulation in capital markets, corporate governance and corporate financing. His work has been published in the top accounting and finance journals and has received several awards and honors, including the Humboldt Research Award in 2012, the 2011 Wildman Medal Award, as well as a JFE All-Star-Paper Award. Professor Leuz is an editor for the *Journal of Accounting Research* and has served on many editorial boards. Born in Germany, he earned his doctoral degree and "Habilitation" at Goethe University Frankfurt.

**Dhananjay (DJ) Nanda** is a Professor of Accounting and Academic Director for the EMBA for the Americas program at the University of Miami School of Business. DJ Nanda received his MS and Ph.D. in Management from the William E. Simon Graduate School of Business, University of Rochester. He teaches Management Accounting, and Compensation Incentive and Strategic Control in the MBA program, and the Empirical Accounting Research Seminar in the doctoral program. DJ's research examines the incentive aspects of performance evaluation and compensation systems as they relate to corporate financial reporting and disclosure activities. His research has been presented at numerous universities, international and national conferences and has been published in the *Journal of Accounting and Economics*, *Journal of Accounting Research*, *The Accounting Review*, *Review of Accounting Studies*, the *Journal of Financial Economics*, and the *Journal of Operations Management*. He currently serves on the editorial boards of *Contemporary Accounting Research* and *Journal of Management Accounting Research*.

**Peter Wysocki** is a Professor of Accounting and the Director of the International Financial Reporting Institute at the University of Miami School. His research interests include the links between the institutions of market economies, international accounting, and the disclosures of U.S. and international firms. His widely-cited research has been published in the *Journal of Accounting and Economics*, the *Journal of Accounting Research*, *Contemporary Accounting Research*, the *Journal of Financial Economics*, and *Accounting Horizons*. Prior to joining the University of Miami, he was an associate professor at the MIT Sloan School of Management and an assistant professor at the University of Michigan Business School. He is an associate editor for the *Journal of Accounting and Economics* and also serves on the editorial board of the *Journal* 

of Accounting Research. He received his undergraduate degree from Queen's University (Canada), his MA in economics from the University of British Columbia, and his MS and Ph.D. degrees from the University of Rochester.

The Distinguished Contribution to Accounting Literature Award was created to recognize accounting research of exceptional merit that has significantly impacted the discipline over a period of at least five years. **S.P. Kothari** is Deputy Dean, overseeing Faculty Affairs and International Programs, and Gordon Y. Billard Professor of Management at the MIT Sloan School of Management, as well as Director of the MIT-India Program. He served as Global Head of Equity Research for Barclays Global Investors from 2008-09. Previously, he was Deputy Dean and earlier was Head of the Department of Economics, Finance, and Accounting at MIT Sloan. His highly cited research focuses on financial reporting and valuation, asset allocation, explaining the diversity in international accounting practices, use of employee stock options for compensating executives, accounting for employee stock options, evaluating investment performance, and corporate uses of derivatives for hedging and speculation. Kothari has been an editor of the world-renowned *Journal of Accounting & Economics* for 17 years. He has written numerous editorials as an expert on economic policy issues in India and has consulted extensively for many large global corporations.

**Susan Shu** is an associate professor in Accounting at the Carroll School of Management at Boston College. She received her PhD from the University of Rochester.
