



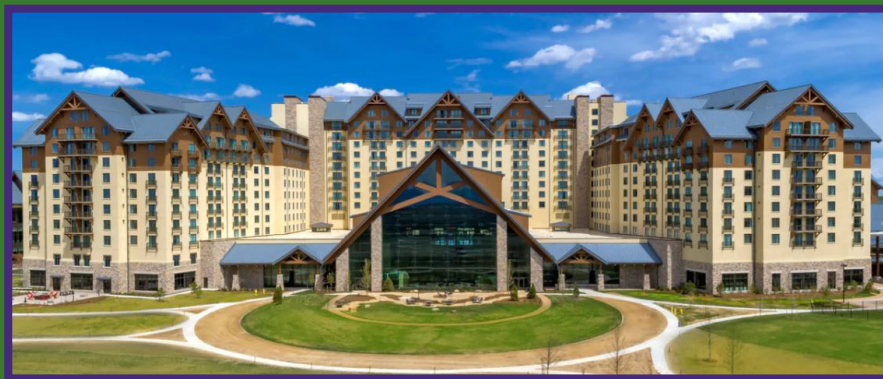

Carla Harris

Carla Harris is a Vice Chairman, Managing Director and Senior Client Advisor at Morgan Stanley, and she will kick off the Annual Meeting as plenary speaker on Monday, August 7. In her 30-year career, Carla has had extensive industry experiences in the technology, media, retail, telecommunications, transportation, industrial, and health care sectors. Carla was named to *Fortune* Magazine’s list of “The 50 Most Powerful Black Executives in Corporate America”, *Fortune*’s Most Influential List, U. S. Bankers Top 25 Most Powerful Women in Finance (2009, 2010, 2011), Black Enterprise’s Top 75 Most Powerful Women in Business (2017), and “Top 75 African Americans on Wall Street.”

She is actively involved in her community and heartily believes that “we are blessed so that we can be a blessing to someone else,” and so her passion lies in helping others.

While climbing the corporate ladder, Carla had her own personal missteps amidst numerous victories. She vowed that when she reached senior management and people came to her for advice, she would provide them with the tools, strategies, and pearls of wisdom honed by her own experience. “Carla’s Pearls” have become the centerpiece for her many speeches and television appearances. Carla is also the author of the books *Strategize to Win* (2014), *Expect to Win* (2009) (Hudson Press), and *Lead To Win* (2022), and the AAA will distribute copies of *Lead To Win* at the 2023 Annual Meeting until supplies run out.

As a Wall Street executive and board member at Walmart and Cummins, Carla will share her perspectives on the value, importance, and role of accounting and financial information for sustaining effective and efficient markets.

Drs. Carolyn M. Callahan, University of Louisville, and **Thomas J. Lopez**, The University of Alabama, have been selected as the 2023 AAA Presidential Scholars and will be our plenary speakers on Tuesday, August 8. Both Dr. Callahan’s and Dr. Lopez’s research has been published in the top accounting research journals, and they have been involved with The PhD Project since it was founded in 1994 with the goal of diversifying corporate America by diversifying the role models in the front of classrooms. Both Dr. Callahan and Dr. Lopez were inducted into The PhD Project Hall of Fame in 2012.

Since 2013, Dr. Callahan has served as the Brown-Forman Endowed Chair and Professor of Accounting at the University of Louisville. Her research interests are focused on the analytical and empirical examination of models that link accounting information to equilibrium prices in aggregate markets, and she has served as an expert witness in litigation matters related to accounting and financial reporting. She also has extensive administrative experience with progressive promotions to central leadership: Associate Provost-Faculty Affairs (University of Louisville,

2014–2015); Dean of the Business School (University of Louisville 2013–2014); Director of the School of Accountancy and PhD Coordinator (The University of Memphis 2009–2013); Associate Provost-Graduate Student Affairs (University of Arkansas 2005–2007); Director of Doctoral Program (University of Arkansas 2001–2004).



Thomas J. Lopez

Since 2009, Dr. Lopez has served as the Steven Ross-Hugh Culverhouse Chair of Accountancy in the Culverhouse School of Accountancy at The University of Alabama. His research interests are primarily in the areas of non-recurring items, executive compensation, and various aspects of analysts' forecasts. He previously served on the editorial board of *The Accounting Review* and has been affiliated with The PhD Project in various capacities since he spoke at their first conference in December 1994.

Siri Lindley, our Tuesday, August 8 Luncheon speaker, is a World Champion Triathlete and High-performance Coach, who barely knew how to swim when she began the training regimen that would lead her to conquer prestigious triathlons such as the ITU World Championships. Today, as the world's former #1 ranked triathlete, an in-demand coach, one of Tony Robbins' favorite motivational speakers, and a cancer survivor, Siri has made it her business to change lives for the better. She shares fear-shattering strategies for changing the thoughts, habits, and behaviors that hold people and organizations back. With an infectious and authentic passion, she empowers audiences to strive for peak performance, work through, and ultimately conquer the demons of fear and self-doubt.

During her pro career, Siri dominated the International Triathlon Union World Rankings; she was the 2001 ITU World Champion, won 13 World Cup races including the World Cup Series in 2001 and 2002, when she was the number one ranked triathlete in the world. As a coach she has mentored and trained numerous #1 ranked triathletes to achieving Olympic medals and World Championship crowns distances.

In late 2019, Siri faced her most difficult battle yet when she was diagnosed with Acute Myeloid Leukemia. Given less than a 10% chance of survival at the time of her diagnosis, she was fortunate to become eligible for a new treatment and was pronounced cancer-free by her doctors in May of 2020. Today Siri helps teams win by living fearlessly, developing the critical traits needed for authentic leadership and building business team mindsets for resilience and success. She establishes a remarkable connection with every audience member and gets to the heart of habits and rituals that drive high performance.

In her book, *Surfacing: From the Depths of Self-Doubt to Winning Big and Living Fearlessly*, Siri offers a breathtakingly honest and bold account of her journey to self-belief and self-discovery and unlocking the champion within. Siri's second book, *Finding a Way: Taking the Impossible and Making it Possible* (2023), provides readers with the tools needed to overcome their struggles and achieve the life they want to live.



Mark H. Taylor

Dr. Mark H. Taylor, AAA President-Elect and Professor at the University of South Florida, will be our plenary speaker on Wednesday August 9 when he will assume the role of AAA President. Mark is the director of the Lynn Pippenger School of Accountancy and began his duties over the summer of 2019, coming from the Weatherhead School of Management at Case Western Reserve University in Cleveland. There, he was the department chair and accounting professor, and was with Case Western Reserve University since 2009 and was the Andrew D. Braden Professor of Accounting and Auditing, teaching courses in corporate governance and auditing assurance areas.

Mark is a past president of the Auditing Section of the AAA, and he also served on the Auditing Section Executive Committee. For three years, he was on the Senior Technical Committee of the American Institute of Certified Public Accountants Auditing Standards Board. He also is the audit committee

chair and independent trustee on three investment company trusts and has had research sponsored by the Center for Audit Quality. Mark earned a doctorate from the Eller School of Business at The University of Arizona and a master's degree in accounting from Brigham Young University's Marriott School of Management.

In addition to the above-listed plenary speakers, the concurrent sessions during the Annual Meeting will include some thought-provoking At-Large panel sessions that we hope you can attend.

2023 Inductees to The Accounting Hall of Fame

It is our pleasure to announce that four new members of The Accounting Hall of Fame will be inducted by the American Accounting Association (AAA) in August 2023 during our Annual Meeting. The Accounting Hall of Fame (AHOF) originated at The Ohio State University in 1950. In 2017, the operations of the AHOF were assumed by the AAA. Since its inception, there have been 113 members inducted into the AHOF.

For 2023, the four inductees represent a diverse group of accounting thought leaders from both practice and educational backgrounds, according to Mary S. Stone, a past president of the AAA who chairs The Accounting Hall of Fame Committee. The nomination process engaged members of The Accounting Hall of Fame, the AAA, and other professional accounting organizations. This year's inductees, Robert Kalb Elliott (1941–2022), William Mitchell Lybrand (1867–1960), Aulana Louise Peters, and Gordon Peter Wilson (1946–2020) are profiled in the following information.

Robert Kalb Elliott (1941–2022)

Although he had “no inkling he would become an accountant” while studying mathematics as an undergraduate at Harvard College, Robert K. (Bob) Elliott became a visionary leader, committed to increasing the relevance of the services provided by Certified Public Accountants (CPAs) while seeking to make that community more diverse. After receiving an MBA from the Rutgers Business School, his career took a path toward accountancy. The international firm KPMG was his base and professional home from 1964–2001. He served as an advisor to six Chairs of the Firm.



Robert Kalb Elliott
(1941–2022)

Known for his direct, intellectual, and outspoken manner, he viewed “accounting as the information infrastructure that permits resources to flow to their highest and best uses,” a necessary but not sufficient condition for a well-running economy. Elliott contributed significantly to widely-read and discussed reports including the *Report of The Advisory Committee on Capital Formation and Regulatory Processes* (U.S. Securities and Exchange Commission, 1996); *Improving Business Reporting—A Customer Focus: Meeting the Information Needs of Investors and Creditors* (AICPA, 1994); and *The Measurement of Corporate Social Performance* (AICPA, 1977). During his career, Elliott contributed to or solely authored more than 100 articles and books. In recognition of his contributions to the accounting literature, Elliott received the American Accounting Association’s 1992 AICPA Wildman Award. Consistent with his scholarly vision, he convinced the KPMG Foundation to create Research Opportunities in Auditing, a program designed to enable research relevant to the accounting profession. In 2002, the Auditing Section of the American Accounting Association chose him to receive its Lifetime Achievement Award.

Elliott envisioned an accountancy “profession that needed to modernize.” He was often far ahead of his contemporaries’ views. In 1997, he was awarded the AICPA’s Gold Medal for Distinguished Service. Focused on the future of the profession, Elliott served on the Strategic Planning Committee and the Special Committee on Assurance Services (the Elliott Committee) of the American Institute of Certified Public Accountants (AICPA) and was Board Chair of the AICPA from 1999–2000.

In his first address as Board Chair to the leadership of the AICPA, he noted that an accounting system was the nervous system of an enterprise that permits the enterprise to perceive and act. Speaking on the eve of the new millennium he said: “I foresee that CPAs will understand the risks and opportunities of the global economy and profit from the international services.” He added:

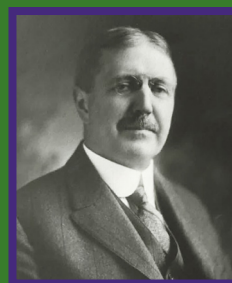
“CPAs will identify and deploy knowledge needed for strategic planning and investments, for marketing decisions, for measuring effectiveness—all this and more.”

Consistent with his focus on the future of the profession, Elliott was a leading proponent of increasing the diversity of the profession. He and his KPMG partner colleague Bernie Milano reasoned that the most expedient way to increase the number of minority students entering the profession was to increase the number of minority educators teaching and conducting research in colleges of business. With the support of the KPMG Foundation and Milano’s leadership, The PhD Project has been credited with quintupling the number of PhD business school minority faculty and, in turn, increasing the number of graduates entering and succeeding in the accounting profession.

Elliott and his wife Lee, childhood friends, were married for 59 years. Their sons David and Don, and their wives, plus grandson Maxim and immediate family are the genealogical heritage of Robert K. Elliott, the 114th member of The Accounting Hall of Fame.

William Mitchell Lybrand (1867–1960)

William Mitchell Lybrand was the son of George and Sarah Ann (Aldred) Lybrand. George was a prominent Methodist minister in Philadelphia, PA. Lybrand married Lenore Dauphina (Montgomery) and they had no children. He contributed to the early practice of cost and public accounting as a charter member of the National Association of Cost Accountants, now the IMA, and as a partner in Lybrand, Ross Bros. & Montgomery, a public accounting firm that became part of Coopers & Lybrand and subsequently PricewaterhouseCoopers, now PwC.



William Mitchell Lybrand
(1867–1960)

Lybrand’s accounting education began as a clerk with Bement and Daughtery, a machine tool company that had adopted a complete cost accounting system. After promotion to assistant book-keeper, he learned the intricacies of the system from its developer, the legendary John Francis. William was early among those who recognized the importance of integrating cost information with the full accounting system.

He was employed by the public accounting firm of Heins and Whelen and gained further knowledge about accounting and auditing. After four years, he became Heins’ junior partner, participating in organizing the public accounting profession in Pennsylvania. In 1898, along with T. Edward Ross, Adam Ross, and Hall of Fame member, and brother-in-law, Robert Heister Montgomery, he formed Lybrand, Ross Bros. & Montgomery, which was a catalyst for a continuous improvement philosophy applied to the technical development of staff and was on the forefront of encouraging formalized education for accountants.

Lybrand was a foundational force in the creation of two professional organizations: the Pennsylvania Institute of CPAs and the National Association of Cost Accountants (NACA). He served as treasurer and then president of the Pennsylvania Institute of CPAs for two terms beginning in 1902. He also was the second president of NACA. His accounting experience and organizational ability enabled him to influence the operational success of NACA. He supported the technical bulletin series that later became the publication *Management Accounting* and now *Strategic Finance*.

He believed that for accounting to be viewed as a profession, formal education was vital. Lybrand taught accounting evening courses sponsored by the Pennsylvania Institute, for which he guaranteed to cover program deficits when adopted by the Wharton School of the University of Pennsylvania.

Lybrand promoted cost accounting in presentations and conferences and made an agreement with Canadian accountants to cooperate on research and publication of papers in business periodicals. His book, *Accounting for Modern Corporations: Prepared Especially for the Instruction and Training*

of *Students of the American School*, was devoted to accounting education. Because of his commitment to education and to honor his work with NACA, in 1949 his partners in Lybrand, Ross Bros. & Montgomery established the Lybrand Gold, Silver, and Bronze medals that the IMA continues to award highly rated articles appearing in *Strategic Finance* and *Management Accounting Quarterly*.

William Mitchell Lybrand is the 115th member of The Accounting Hall of Fame.

Aulana Louise Peters

Born Aulana Louise Pharis in Shreveport Louisiana in 1941, the daughter of Clyde A. and Eula Mae (Faulkner) Pharis, Peters studied philosophy and earned a Bachelor of Arts degree from the College of New Rochelle (1963) and earned her Juris Doctor degree from the University of Southern California in 1973. Although not an accountant, Peters has had a profound and sustained influence on accounting and auditing scholarship, professional practice, professional standard setting, and corporate governance. She is a retired partner with Gibson, Dunn, and Crutcher LLP who focused on accountants' liability and securities litigation. Her husband, Bruce, is a retired physician.

Among her distinctive service is her role as a Commissioner on the U.S. Securities and Exchange Commission from 1984–1988. She was the first African American and the third woman to serve on the Commission. In 2003, the Association of Securities and Exchange Commission Alumni named her the 11th recipient of the William O. Douglas Award for having made significant contributions to the development of the Federal Securities Law, to the SEC, and to the financial community. In 2008, she received the Horatio Alger Award, which recognizes dedicated civic, corporate, and cultural leaders who succeeded despite adversity. In 2010, she was awarded the Medal of Honor by the American Institute of Certified Public Accountants (AICPA) for distinguished service to the accounting profession by a non-accountant.

Peters' ability to relate securities law to investors' interests and the practicalities of accounting measurement and disclosure of risks made her a valuable contributor to the deliberations of the Financial Accounting Standards Board Financial Accounting Standards Advisory Council (1989–1992), the Steering Committee for the Financial Accounting Standards Financial Reporting Project (1990–1992), AICPA Board of Directors and Governing Council (1992–1994), Panel on Audit Effectiveness (1998–2000), Public Company Accounting Oversight Board of the AICPA (2000–2002), International Federation of Accountants' Public Interest Oversight Board for Auditing, Education and Professional Ethics Standards (2005–2012), and United States Comptroller General's Accountability Advisory Council (2001–2020).

Her service on public company boards of directors has included manufacturing, financial, and aerospace corporations. Because of her understanding of the audit profession and her demonstrated commitment to the public interest, Peters testified before Congress in the legislative hearings prior to the passage of the Sarbanes-Oxley Act. She subsequently served on the Public Company Accounting Oversight Board's Advisory Council (2007–2013).

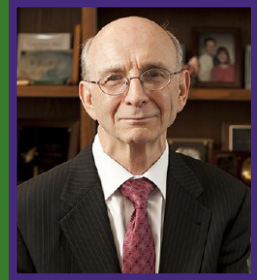
An early advocate of international accounting standards and for disclosure to investors of material information on Environmental, Social, and Governance (ESG) matters and for the establishment of standards to guide those disclosures, she served as a director of the Sustainability Accounting Standards Board Foundation from 2013 to 2016.

Gordon Peter Wilson (1946–2020)

Gordon Peter “Pete” Wilson held the Joseph L. Sweeney Chair of Accounting at Boston College. He was an exemplar of a master teacher and scholar who devoted his career to helping colleagues and members of the American Accounting Association become better accounting teachers and researchers. He earned his Ph.D. in Industrial Administration from Carnegie Mellon University (1985). Before his appointment at Boston College in July 1997, he taught at Stanford University (1985–1989), Harvard University (1989–1994), and the Massachusetts Institute of Technology (MIT) (1994–1997).



Gordon Peter Wilson
(1946–2020)

First and foremost, Wilson was a master teacher who became a teacher-of-teachers, who inspired others to make a difference. His overarching goals were to help students and other educators develop robust conceptual frameworks to navigate complexity and uncertainty; build relationship skills that promote effective and rewarding interactions with others; and gain a passion for lifelong learning. The aim was a more prosperous society.

Evidence of students’ and colleagues’ respect for Wilson is provided by the many awards he earned: Distinguished Teaching Award (Stanford Business School, 1988); Teacher of the Year Award (MIT Sloan School of Management, 1995), the AAA Outstanding Educator Award (2005), Teaching with New Media Award (Boston College, 2009, 2010), AICPA Distinguished Achievement in Accounting Education Award (2010), AAA Two-Year Section Lifetime Achievement in Accounting Education (2014), AAA Financial Accounting and Reporting Section Innovation in Accounting Education Award, and the J. Michael and Mary Anne Cook/Deloitte Foundation Prize (2016), the foremost recognition of an individual who consistently demonstrates the attributes of a superior teacher. When complimented on the many awards he had received, Wilson often responded that the students were largely responsible for the success of his classes. He described becoming a great teacher as a journey from me (the teacher) to we (the students and teacher). Many of his most popular and widely used educational materials were developed with his wife and collaborator Carolyn Ruth Wilson.

Wilson’s teaching philosophy and passion for student learning reached beyond the classroom. For example, he was the 2002–2003 President of the American Accounting Association, extending his influence to a national and global audience of accounting educators and professionals. This was amplified through his work on the Accounting Education Change Committee (1993–1996) and the Pathways Commission (2013).

Wilson’s lasting contributions to accounting research include seminal articles disentangling the differential contributions of earnings and cash flows to stock price reactions to a company’s annual report (e.g., “The Incremental Information Content of the Accrual and Funds Components of Earnings After Controlling for Earnings, *The Accounting Review*, April 1987) and showing the magnitude and timing of corporate decisions associated with major changes in tax regulation (e.g., “Tax Planning, Regulatory Capital, and Financial Reporting Strategy for Commercial Banks, *Review of Financial Studies*, 1990 with Myron Scholes and Mark Wolfson). He supervised the Ph.D. dissertation of six students. His influence was evidenced in his work as a member of faculty for sixteen AAA/Deloitte Foundation/J. Michael Cook Doctoral Consortia.

Upon the award of emeritus status at Boston College, he and Carolyn moved to Tampa, Florida to be closer to family.

Gordon Peter Wilson is the 117th member of The Accounting Hall of Fame.

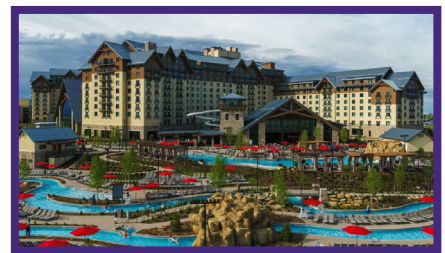

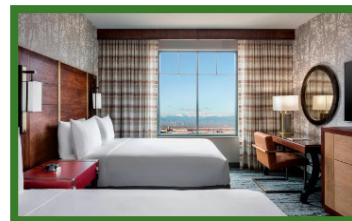

Do accounting ethics inspire you? If so, then the **27th Annual Ethics Research Symposium** is for you! All AAA members are invited to attend the Symposium on Sunday, August 6, 2023, preceding the AAA Annual Meeting in Denver, CO.

Classic perspectives of ethics and accounting place them at the core of the accounting profession's obligation to serve the public interest and honor the public trust. Beyond the profession's obligation, accounting scholars have an obligation to highlight the role of ethics, accountability, and responsibility and the impact of accounting on society. These themes have never been more important and play a critical role in investigating causes and consequences of (un)ethical practice and policy at the systemic, organizational, and individual levels.



Accounting Ethics Research Symposium

The Symposium encourages thoughtful research on the ethical applications of teaching, practice, and/or business that ultimately benefits the individual, government, or society. Accordingly, we challenge researchers in other accounting areas to identify and address the ethical implications of their research. The Accounting Exemplar Award and the Excellence in Accounting Ethics Education Award will be presented by the Public Interest Section during the Symposium. In addition, the Symposium will recognize other research, including Best Research Paper, Best Innovation for Teaching, Best Paper by a current doctoral student, or Best Paper by an early career scholar (graduation from a doctoral program must have occurred within the last 3 years).

Registration for the Symposium is restricted to current AAA members. The registration fee is \$275 and includes breakfast and the Accounting Exemplar Luncheon. **Note:** You will not be able to register after July 26, 2023.

Academy of Accounting Historians Section 50th Anniversary Celebration

Save the Date!

1973

On August 15, 1973, at the Faculty of Business Administration Building at Université Laval in Quebec, Canada, those academicians interested in accounting history met during the Annual Meeting of the AAA and formed The Academy of Accounting Historians. Gary J. Previts, who chaired the meeting, was elected President and Alfred R. Roberts was elected Secretary of the newly formed Academy.



The Academy was established to serve as an autonomous, service-oriented organization to assist academicians and practitioners throughout the world to further their study in the many aspects of the evolution of accounting thought and practice. In particular, the concept of The Academy was:

- To demonstrate the relevance of history to contemporary accounting.
- To encourage scholarly work and exchange of ideas among historians pursuing accounting subjects.
- To establish activities such as workshops and seminars to assist in developing and disseminating historical methodology.
- To promote the teaching of historical subject matter as a part of existing coursework and as part of unique historical curricula.
- To coordinate activities with international accounting history groups in European countries, Australia, India, and other countries.
- To emphasize the need for continued research in accounting history, both developmental history and thought history, by employing conceptual, quantitative, and experimental models.

The Academy of Accounting Historians was incorporated as a not-for-profit organization under the laws of the State of Alabama and registered in the Tuscaloosa County Courthouse on December 28, 1973. W. Baker Flowers, S. Paul Garner, and Gary J. Previts, all residents of Alabama, served as directors of the corporation. Early in 1974, The Academy was granted provisional tax-exempt status by the Internal Revenue Service.
