Welcome from 2022–2023 AAA President Mark C. Dawkins

At the 2022 American Accounting Association (AAA) Annual Meeting in San Diego, CA, I was installed as the first Black President of the AAA in its 106-year history. I was honored to stand before the Annual Meeting attendees, and I received a standing ovation for this achievement. I assure you I had spent many hours prior to this moment reflecting on all the Black, Brown, and ally faculty who preceded me in the AAA and the accounting academy on whose giant shoulders I was standing. I thanked all AAA members who supported my nomination and selection as president, and I gave special thanks to all AAA staff and member volunteers who serve on the Management Team, the Board of Directors, and the Council since the successful operation of the AAA is truly a team effort. It is a pleasure to serve with the outstanding AAA staff and AAA members who unselfishly volunteer their time and expertise to serve our organization. I thanked past Council Chair Monte Swain and noted that I looked forward to continuing to work with President-Elect Mark Taylor and new Council Chair Sydney Askew. Lastly, I thanked AAA past-Presidents Elaine Mauldin and Robert Allen, and AAA CEO Yvonne Hinson for helping me prepare to lead the AAA this year, and I invite all AAA members to join me on our journey focused on “Sustaining Our Profession.”

The title of my Annual Meeting Plenary presentation was “Declining Enrollments—A Call to Action!” and so my focus this year within the theme of “Sustaining Our Profession” centers on the challenges 1) accounting programs, 2) accounting faculty, 3) accounting firms, 4) accounting regulatory organizations (i.e., the American Institute of Certified Public Accountants (AICPA), the National Association of State Boards of Accountancy (NASBA)), 5) other accounting organizations and state societies (i.e., the AAA, the Institute of Management Accountants (IMA), the Center for Audit Quality (CAQ), the National Association of Black Accountants (NABA), the Association of Latino Professionals for America (ALPFA), the California Society of Certified Public Accountants (CalCPA), the International Federation of Accountants (IFAC), etc.), and 6) standard setters (i.e., the Financial Accounting Standards Board (FASB) and the Governmental Accounting Standards Board (GASB)) and industry regulatory agencies (i.e., the United States Securities and Exchange Commission (SEC) and the Public Companies Accounting Oversight Board (PCAOB)) face as a result of declining enrollments in accounting.

The following data are from my forthcoming commentary entitled “Declining Enrollments—A Call to Action!” in the February 2023 *Issues in Accounting Education* (it should be online in November 2022). Before addressing accounting enrollments, let me first address undergraduate enrollments. Per May 26, 2022, data from the National Student Clearinghouse Research Center (NSCRC), undergraduate enrollments at public colleges and universities declined 4.7 percent from spring 2021–spring 2022, which followed a 4.9 percent decline from spring 2020–spring 2021. Thus, enrollment of undergraduate students fell 9.4 percent in two years, or nearly 1.4 million students. The spring 2020–spring 2022 undergraduate enrollment decline of 9.4 percent is the largest in 50 years and exceeds the fall 2019–fall 2021 undergraduate enrollment decline of 6.6 percent or 1.0 million students. Unfortunately, per preliminary NSCRC data released on October 20, 2022, the undergraduate enrollment decline continued in fall 2022 with a 1.1 percent decline from fall 2021. Over the past decade, enrollment of undergraduate students fell 2.6 million students which represents a troubling decline in undergraduate student enrollment that started in 2011.

Now shifting to examine accounting enrollments, the 2019 AICPA Trends report indicates that projected bachelor’s, master’s, and Ph.D. accounting enrollments were down 4 percent, 6 percent, and 23 percent in 2018 relative to 2016, respectively, and the number of new CPA exam candidates hit a 10-year low. And so,

even though overall accounting student enrollment decreased in 2018 relative to 2016, the 2019 AICPA *Trends* report indicated that racial/ethnic diversity increased in the 2017–2018 academic year, with universities reporting increases in Hispanic or Latino accounting enrollees of 3 and 8 percentage points at the bachelor's and master's levels, respectively. Thus, recruiting more diverse students will be increasingly important going forward, particularly during the next 15 years as high school graduates peak in 2025 and return to 2014 levels by 2037.

Per the 2021 AICPA *Trends* report, "Accounting graduates trended downward in the 2019–2020 academic year, with decreases of 2.8% and 8.4% at the bachelor's and master's levels, respectively." Per the 2019 AICPA *Trends* report, "...projected accounting graduates trended downward in the 2017–2018 academic year, with decreases of 4% at both the bachelor's and master's levels and overall." Thus, accounting programs have been experiencing declining graduates at the bachelor's and master's levels since at least 2016, *which has significant implications for the sustainability of accounting programs and accounting faculty positions at most colleges and universities.*

In 2020, accounting firm hiring of new accounting graduates decreased 10 percent, which followed an 11 percent decrease in accounting firm hiring of new accounting graduates from 2016 to 2018. Thus, across the last two AICPA *Trends* reports, the percentage of all new graduate hires by accounting firms who were non-accounting hires increased 11.7 percent from 2018 to 2020, representing 42.7 percent of all hires by accounting firms in 2020, up from 31 percent of all hires by accounting firms in 2018. *This trend in accounting firms hiring more non-accounting graduates is a significant challenge to the sustainability of accounting programs and ultimately the number of accounting faculty universities and colleges need in the future.*

Todd Shapiro, President & CEO of the Illinois CPA Society, states in the Illinois CPA Society's 2021 "A CPA Pipeline Report—Decoding the Decline": "...we are witnessing a nationwide decline in not just new CPAs but also accounting program enrollments." Five years earlier in 2016, he issued the following warning in the 2016 Insight Special Feature, "Pipeline Disruption: The Search for Solutions to the Weakening Supply of CPAs": "A stagnating CPA pipeline is a threat. It's an issue that will only get worse and grow more troubling without action." Unfortunately, the 2021 report notes that "five years later the issue has grown worse and more troubling."

Where do these undergraduate and accounting enrollment challenges leave 1) accounting programs, 2) accounting faculty, 3) accounting firms, 4) accounting regulatory organizations, 5) other accounting organizations and state societies, and 6) standard setters and industry regulatory agencies with respect to addressing declining enrollments in accounting? For a more detailed discussion regarding declining enrollments and a list of recommendations for each group, please see my forthcoming *Issues in Accounting Education* commentary. Also, please share and discuss the commentary and recommendations with your Advisory Boards and local firms that recruit your accounting students, and email me any additional recommendations that should be added to the list.

I look forward to working with you and for you this year as your President. Please contact me directly if you have ideas or suggestions for how the AAA can better support its members this year and beyond.

We welcome them to the Recruiting and Research Camp and appreciate their sponsorship of this important conference.


We are now busy planning for the winter and spring midyear meetings, as well as the conference “Sustainability, ESG, and Accounting: Implications for the Academy and the Profession.” We hope that you will check out our upcoming meetings at <https://aaahq.org/Meetings/AAA-Meetings>.

We are continuing our transition to new vendors on the publications front. Please look for announcements coming up as we integrate Aries and Silverchair-direct into our systems where you will enjoy single sign-on for the Digital Library. Please be aware you may need to go into your profile and update it the first time you sign on. We also already have papers making their way through our new production vendor, KGL. You should start to see the advantages of faster production on accepted papers as we begin putting 2023 papers into the process. In addition, accepted articles produced by KGL will appear as Early Access content in the AAA's Digital Library and be fully copyedited, typeset, and proofed. Accepted papers can start collecting citations prior to the final version being assigned volume, issue and page numbers. Early Access content will be available to members and more widely through EBSCO. I am pleased to share that EBSCO has agreed, starting January 2023, to allow 90 percent of our Early Access content to be free to read in our Digital Library for 90 days or until placed into a journal. This will make our articles much more visible to the practitioner community. Early Access content will be replaced with the final Version of Record upon issue publication, which will be more widely available through EBSCO, JSTOR and to members worldwide. As I wrote in the summer, we are seeking members for a new Practitioner Advisory Board. This Board will advise us on our articles most relevant to practice. We will then put those articles into a more practitioner friendly form and will ultimately create a website to host these. If you know of any practitioners you would like to recommend, please email Stephanie Austin at Stephanie.Austin@aaahq.org.

We have just started a new task force—our Regions Meeting Task Force. We look forward to the input from many of our volunteer members as we decide how to make our Regional meetings much more sustainable in the future and structure them to attract a wider audience. In addition, we are now working with a group of volunteers to find a replacement for our meetings submissions systems. We are currently running two separate systems and our Board identified these as a major point of risk for AAA. We greatly appreciate the support of all of our many volunteers, as we cannot operate as a membership organization without this volunteer support. 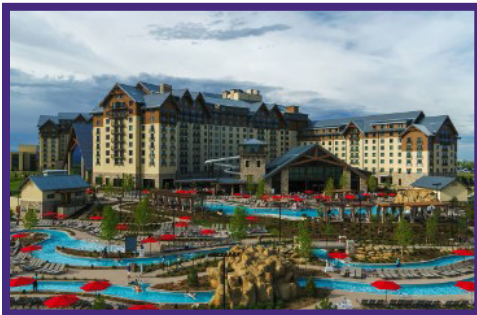

General Information:

The Annual Meeting is sure to be a large, dynamic meeting that encourages participation through a wide range of session types designed to support members with different interests. You can learn more about the session types below, and you can submit to each through the links provided for each type. To track your submission, you will need to create a user ID and password during the submission process. You will need this information to update and/or access the status of your submission. This user ID and password does not need to match your AAA login, and will not grant access to AAA member services (i.e., registration, dues renewal, etc.), however, it is recommended to use your AAA login. If your submission is accepted, all participants and presenters must register for the meeting which includes both meeting registration and membership fees.

Concurrent Paper and Research Forum Sessions—Submission Deadline: **Monday, January 9, 2023**

Papers are sought for presentation on topics of interest to accounting researchers, educators, and practitioners. Submissions are made by section/topic area.

NOTE: To ensure the quality of submissions and to support the technology costs related to the meeting, there is a non-refundable submission fee of \$50. The fee is required and must be paid before submitting a paper in this category. If submitting more than one paper, you may pay for all at one time. Please follow instructions on the Submission payment form.

Authors may submit more than one paper to the Annual Meeting. However, it is considered an abuse of valuable reviewer and liaison time to submit the same paper to more than one Section Designation. Submitting the same paper to multiple Sections will disqualify your submission from consideration. Consult appropriate Section Liaisons should you have questions about where to make your submission.

Concurrent Panel Sessions—Submission Deadline: **Monday, January 9, 2023**

Panel session submissions are sought that address issues of practice, scholarly projects and findings, teaching and curriculum approaches, and initiatives. Panel proposals are submitted to section/topic area. Section leaders are encouraged to consider developing panel sessions addressing linkages between the private and public sector as they relate to issues affecting their members.

Pre-Conference Workshops (CPE Sessions)—Submission Deadline: **Monday, January 9, 2023**

Opening the engaging pre-meeting format, these full- and half-day workshops provide opportunities for in-depth attention and study of more complex issues and topics across a wide range of areas of interest in accounting education, research, and practice. These sessions will be held on Saturday, August 5 and Sunday, August 6, 2023.

The Conference on Teaching and Learning in Accounting (CTLA)—Submission Deadline: **Thursday, February 9, 2023**

Designed for new and experienced faculty looking for opportunities to share best practices, refine teaching talents, and perfect their craft in teaching Accounting, submissions are invited for this annual pre-meeting conference. Submissions are welcome from the wide range of approaches and content in accounting education. This conference will be held all day Saturday, August 5 and during the morning on Sunday, August 6, 2023.

27th Annual Ethics Research Symposium—Submission Deadline: **Thursday, February 9, 2023**

Colleagues engaged and interested in research and teaching related to Ethics are invited by the Public Interest Section of the American Accounting Association to submit papers, cases, and panel session proposals for presentation at the 27th Annual Ethics Research Symposium to be held on Sunday, August 6, 2023. Contributions from members of all AAA Sections are invited.

Interactive Sessions:

These sessions are presented in a shared interactive forum for the exchange of ideas and resources that support learning in accounting. We recommend you review the presentation guidelines to understand presenting in this format, and to see suggestions on how presentation materials are prepared for an interactive session. **NOTE:** Authors may submit to both of these sessions; however, they should not submit the same presentation to both sessions.

• **Effective Learning Strategies (ELS) Interactive Session**—Submission Information Coming Soon

Members interested in sharing learning-related interests and projects, scholarship of teaching projects, and educational innovations are encouraged to submit proposals that showcase ideas, research, strategies, and education innovations that support learning in accounting.

• **Emerging and Innovative Research Interactive Session**—Submission Deadline: **Wednesday, April 5, 2023**

Intended to highlight promising emerging and innovative research ideas, authors will submit a short abstract of three to four pages that describes their work in progress or a planned proposal that will bring ideas currently outside Accounting to the attention of Accounting scholars.

Faculty-Student Collaborations in Accounting-FASTCA-23—Submission Deadline: **Wednesday, May 10, 2023**

Encouraging exploration and discussion of collaborations between accounting faculty and undergraduate and master's students, this all-day conference recognizes the importance of these collaborations to creating important learning experiences for students, attracting students to the accounting profession, and the accounting academy—as well as connecting the community of faculty conducting collaborative research and teaching. The following are some examples of faculty-student collaborations: (1) Research: Students and faculty working together on a research paper; (2) Teaching: Joint development of teaching materials by students and faculty; and (3) Practice: Students and faculty working together to solve a real-world problem.

Global Emerging Scholars Research Workshop—Submission Deadline: **Wednesday, May 10, 2023**

The American Accounting Association Global Emerging Scholars Research Workshop will be held on Sunday, August 6, in conjunction with the 2023 AAA Annual Meeting. Up to 16 proposals will be selected for presentation at the Workshop. At the Workshop, each scholar will present the proposal, followed by discussion by a senior researcher as mentor who will also provide constructive feedback. There will also be further discussion of the proposal by the presenter, other senior scholars as mentors, and the other early career researchers.

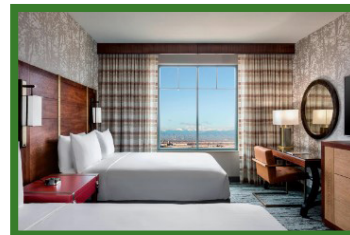

Nominate Now for the 2023 AAA Awards:

Research Awards

- **AAA-AACSB-RRBM Award for Research Impacting Societal Challenges—New AAA Award!** - This award is given annually to recognize work based on its impact to society of responsible research in accounting. Responsible research is defined as research that produces both useful and credible knowledge addressing problems important to policy-setters, organizations, and society. Selected works must have been published in the previous three years. The recipients receive a \$5,000 prize.
- **Competitive Manuscript Award** - This award is given annually to up to three papers selected based on interest in their subject matter, depth of research, contribution to knowledge, and organization of subject matter. Papers must be sole authored by current PhD students or scholars receiving their PhDs within the previous five years. Manuscripts under review at another journal and previously published manuscripts are not eligible.
- **Deloitte Foundation Wildman Medal Award** - This award is given annually to work which is judged to have made or will make the most significant contribution to the advancement of practice in any area. Selected works must have been published within the previous five years and receive a medal and \$5000 prize.
- **Distinguished Contributions to Accounting Literature Award** - This award is given annually to recognize work based on its uniqueness and magnitude of contribution to accounting education, practice and/or future research, and its originality and innovation. Selected works must have been published between five and fifteen years ago and receive a \$2,500 prize.
- **Notable Contributions to Accounting Literature Award** - This award is given annually to recognize work(s) based on their contribution to accounting education, practice and/or future research, breadth of interest, and originality. Selected works must have been published in the previous five years and receive a \$2,500 prize.

Teaching Awards

- **Innovation in Accounting Education Award** - To encourage innovation and improvements in accounting education.
- **Outstanding Accounting Educator Award** - To recognize outstanding service to the Association other than educational and research contributions.

Service Award

- **Lifetime Service Award** - Recognizes service contributions to accounting education over a sustained period of time by members whose career contributions have made a significant impact beyond their own institutions.

Excellence in Accounting Ethics Education Award

Excellence in Accounting Ethics Education Award

The intent of this award is to recognize new pedagogy for teaching ethics to accounting students. A monetary award of \$1,000 and a plaque will be presented at the annual Ethics Symposium to an individual (or individuals) who has (have) developed and implemented an innovative technique/method for incorporating ethics into undergraduate or graduate accounting courses.



AWARD CRITERIA

Examples of innovative techniques/methods include, but are not limited to:

- Developing a case, video, audio, or other teaching techniques that can be used to integrate ethics into the accounting curriculum;
- Developing a new course in accounting ethics including learning objectives and assessment techniques;
- Application of technology to teach ethics to accounting students including digital learning tools; or
- Application of E-Learning activities to enhance interaction with students in the classroom on ethics issues and the benefits therefrom.

Applicants should explain how they shared their pedagogical innovation with the public, which may include one or more of the following:

- Presentation at a seminar, workshop, or other form of public appearance; or
- Publication (or acceptance for publication) in a refereed journal; or
- Other form of communication.

Electronic submissions only should be sent and demonstrate support for how the pedagogical innovation advances accounting ethics education by including one or more of the following (as applicable):

- Identification and description of the course, seminar, or workshop in which the innovation is (was) used;
- Submission of the case, video, audio, or other innovation, along with teaching notes;
- Copies of instructional materials used in E-Learning activities;
- Detailed explanation of how digital learning tools support teaching and learning;
- Assessment results on the new pedagogy (i.e., efficacy survey, student performance, improvement in student performance); or
- Copy of the refereed journal article that was published or accepted for publication along with the official notification from the editor of the journal indicating acceptance.

In addition, all applicants should submit both of the following:

- A 500-word statement describing the contribution to accounting ethics education; and
- Two letters of recommendation from educators in support of the nominee for the award and elaborating on the contribution of the technique to accounting ethics education.

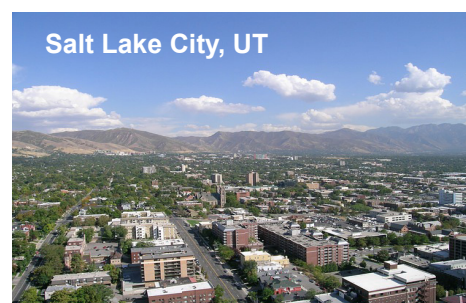
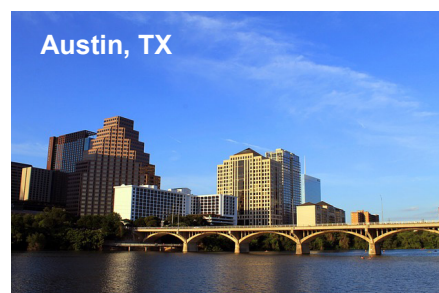

Academy of Accounting Historians Section 50th Anniversary Celebration

Save the Date!

1973

On August 15, 1973, at the Faculty of Business Administration Building at Université Laval in Quebec, Canada, those academicians interested in accounting history met during the annual meeting of the AAA and formed The Academy of Accounting Historians. Gary J. Previts, who chaired the meeting, was elected President and Alfred R. Roberts was elected Secretary of the newly formed Academy.



The Academy was established to serve as an autonomous, service-oriented organization to assist academicians and practitioners throughout the world to further their study in the many aspects of the evolution of accounting thought and practice. In particular, the concept of The Academy was

- To demonstrate the relevance of history to contemporary accounting.
- To encourage scholarly work and exchange of ideas among historians pursuing accounting subjects.
- To establish activities such as workshops and seminars to assist in developing and disseminating historical methodology.
- To promote the teaching of historical subject matter as a part of existing coursework and as part of unique historical curricula.
- To coordinate activities with international accounting history groups in European countries, Australia, India, and other countries.
- To emphasize the need for continued research in accounting history, both developmental history and thought history, by employing conceptual, quantitative, and experimental models.

The Academy of Accounting Historians was incorporated as a not-for-profit organization under the laws of the State of Alabama and registered in the Tuscaloosa County Courthouse on December 28, 1973. W. Baker Flowers, S. Paul Garner, and Gary J. Previts, all residents of Alabama, served as directors of the corporation. Early in 1974, The Academy was granted provisional tax-exempt status by the Internal Revenue Service.

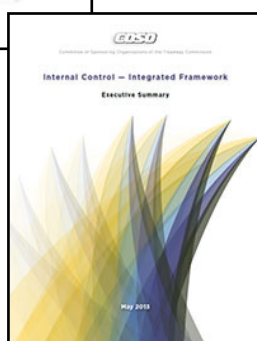
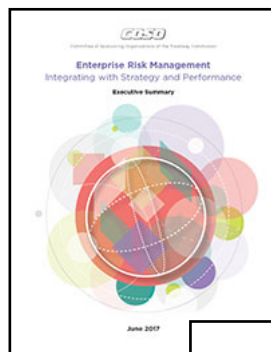
