Education Updates: Our work to support enrollments by working to increase the number of students pursuing accounting as a major continues through multiple initiatives. (FASSSO) and their four working groups are making great progress. The Principles Working Group will hold a pilot workshop just prior to the joint TLC/Diversity Meeting in October titled "How to Interest Students in Principles Courses in the Accounting Profession</a>." This workshop will be held the morning of the Diversity and TLC Sections joint meeting, and registration is limited to 35!

The Center for Advancing Accounting Education has now held over 100 **weAREs**! See the website for recordings of these webinars that focus on both research and educational issues and other topics of interest. In addition, the Center is completing work on a Learning Management System that will make access to cases and educational resources easily accessible.

**Meeting Updates:** Winter and Spring meetings are now receiving submissions and registration is open for many. Some new venue experiences await as four sections hold their meetings at university locations offering a varied experience for attendees. **General HQ Updates:** We continue to have our building on the market. Kaiser Consulting took over most of our finance functions when we outsourced this in Spring 2024. While we continue to work through all the transition issues due to a former very manual system, we are making progress, although slowly. In addition, the Board reviewed our programs for all membership groups at the May 2024 Strategic Retreat. They identified some additional programming in multiple areas that will benefit retirees, students, international members, community college faculty, research focused faculty and teaching focused faculty. The American Accounting Association (AAA) congratulates Kimberly Swanson Church, Jennifer M. Cainas, and Carolyn Christesen as recipients of the 2024 AAA/J. Michael and Mary Anne Cook/Deloitte Foundation Prize. Kimberly Swanson Church is the recipient of the graduate award, Jennifer M. Cainas is the recipient of the undergraduate award, and Carolyn Christesen is the recipient of the two-year college award.

The awards were presented to each recipient in the form of a solid silver medal and a monetary prize of \$30,500 on Monday, August 12 at the 2024 Annual Meeting. The American Accounting Association/J. Michael and Mary Anne Cook/Deloitte Foundation Prize is the foremost recognition of an individual who consistently demonstrates the attributes of a superior teacher in the discipline of accounting. The prize serves to recognize, inspire, and motivate members to achieve the status of a superior teacher. Each year up to three awards of \$30,500 each can be made in the categories of graduate, undergraduate, and two-year accounting degree programs.

#### Graduate Prize - Kimberly Swanson Church, MIssouri State University

"My educator goal is to preserve knowledge and inspire learning. I seek engagement across the accounting pipeline with a balance of project-based knowledge, task application and terminology discussions using gamification and other experiential learning methods. I emphasize knowledge collaboration to empower, excite and develop problem-solvers necessary for an evolving career in the accounting profession.

My primary teaching area is information systems, data analytics and emerging technology. My teaching philosophy provides a compelling opportunity to lead by example as I take students on a learning journey as we master the course content that exists at the intersection of emerging technologies and innovation within the accounting profession. This goal is achieved through partnerships with firm experts to ensure content and pedagogy are consistent with cutting-edge accounting practices. My hope is to create a core competency model that results in enthusiasm for accounting that entices students into and through the accounting pipeline toward successful completion of the CPA exam."

#### Undergraduate - Jennifer M. Cainas, University of South Florida

"Education is the greatest enabler of social mobility; it can help people achieve their dreams. I have several key priorities that I strive to facilitate within all my classes: student engagement, active learning, critical thinking, mutual respect, and building class community.

I recognize that students are often intimidated by an accounting class, especially in a large, mass lecture hall with over 450 students. On the first day of classes, I immediately try to set a tone of a cooperative, engaged learning environment. I want students to feel comfortable and included, so that they will ask questions and participate in our discussions throughout the semester. I also impress upon my students that our relationship is a partnership, and each of us has responsibility for the learning process.

I try to change those perceptions from the first day of classes by immediately engaging students through storytelling and real-world examples. My goal is to make accounting interesting and relevant to all students, introduce them to the profession, and attract as many students as I can to pursue an accounting degree. By teaching the introductory courses, I am humbled to possibly impact a student's career trajectory."

# **Two-Year College - Carolyn Christesen**, SUNY Westchester Community College "My teaching philosophy includes the belief that any student can learn Accounting if they are in a safe, structured, student-centered environment where there is a sense of community and belonging. I also believe in continuous improvement by embracing change in our curriculum and my courses.

Having a safe, structured, student-centered environment includes finding a balance between being firm, being transparent with grading and class expectations, and being understanding when situations arise that require flexibility. I have a saying in my classes, "You are either right or you are learning." This tells students that an incorrect answer is part of learning and I make it clear that I use their incorrect answers to understand how to better explain a concept.

Building a sense of community and belonging is important in a community college where many students come to the classroom underprepared for college work and are often unsure of their ability to succeed in college. Students in my classes have a chance to work with peers regularly, helping them see that other students haven't mastered the content and giving them a chance to help classmates when they can. "


## The 28th Annual Ethics Research Symposium

### 2024 Faculty-Student Collaborations in Accounting (FASTCA-24)

The 2024 Annual Meeting hosted the Faculty-Student Collaborations in Accounting Workshop (FASTCA-24), a daylong workshop that explores and examines innovative ideas for faculty collaborations with undergraduate and master's degree students. This year, the workshop received 16 submissions, of which 10 were presented at the Annual Meeting.

FASTCA is an all-day conference at the Annual Meeting that recognizes the importance of fostering faculty and student collaborations to facilitate memorable learning experiences for students, as well as to attract students to the accounting profession and accounting academy, and to connect the community of faculty conducting collaborative research and teaching.

### 2024 Global Emerging Scholars Research Workshop

The Global Emerging Scholars Research Workshop was held on Sunday, August 11, 2024 in conjunction with the 2024 AAA Annual Meeting. The workshop was held for scholars who are in the early stage of their research careers and are primarily focused on helping early career stage accounting scholars based in emerging countries.

The main objective of the workshop is to help scholars who do not have local senior leadership to develop their research. The scholars who attended the workshop presented their papers and received constructive feedback from senior mentors and their fellow scholars.

This year, 5 workshop attendees had the opportunity to interact with renowned scholars of international standing and with fellow early career researchers. In addition, the workshop provided a platform for the discussion of research ideas and issues that potentially lead to future collaboration among attendees. The 2024–2025 Board of Directors began their service at the 2024 AAA Annual Meeting.


