We have new and exciting sessions already being planned for you.

Many of our members are concerned about the accounting pipeline and the shortage of students enrolling in their programs. I wanted to take this opportunity to let you know how the AAA is engaging on this issue. As 2023-2024 Board President Mark Taylor announced at the Annual Meeting last month, the AAA is holding a Symposium in Washington, DC, on September 28-29, 2023. This Symposium is being co-hosted by NABA and is reflective of the accounting profession, very broadly defined. It includes approximately 80 representatives from firms, associations, organizations, regulators, government, as well as educators from high schools, community colleges and four-year colleges and universities. These stakeholders are coming together from a broad constituent group to work on initiatives that will induce many more students to consider accounting, broadly defined, as their major. We will update you on outcomes and next steps after the Symposium. In addition, the AAA Leadership in Accounting Education Section is working with Senior Director Karen Osterheld of the Center for Advancing Accounting Education to promote best practices through a [Pipeline Webinar Series](#). The Leadership Section is also pulling together best practices across educational institutions on successful pipeline initiatives and programs. There will be a searchable website with these initiatives and programs so that you can easily identify them by type of program, topic, course, etc. Contact information for these will also be provided so that you can reach out directly to the educational program. We are also seeking input from our members on how the AAA should further engage. If you have input, please feel free to email me directly or to reach out to Info@AAAHQ.ORG.

President Taylor also announced last month the creation of the [American Accounting Association Foundation](#). The Foundation's goal is to ensure a vibrant and thriving Accounting Profession. The American Accounting Association Foundation supports programs and initiatives that advance accounting education, the accounting academy, and the accounting profession. The Foundation will accomplish this through five pillars: Supporting Teaching Excellence, Supporting Research Relevance and Impact, Supporting Advanced Degrees in Accounting, Raising Awareness of the Accounting Profession, and Advancing Diversity, Equity, Inclusion, and Belonging in the Accounting Profession. Funding for this Foundation will not be solicited through the normal AAA funders, but rather through large, broad Foundations that support these initiatives. Thank you to our inaugural Board of Trustees and, in particular, George Krull, for chairing the Board.





The American Accounting Association (AAA) congratulates Christine Cheng, Wayne Thomas, and Larry G. Stephens as recipients of the 2023 AAA/J. Michael and Mary Anne Cook/Deloitte Foundation Prize. Christine Cheng is the recipient of the graduate award, Wayne Thomas is the recipient of the undergraduate award, and Larry G. Stephens is the recipient of the two-year college award.

The awards were presented to each recipient in the form of a solid silver medal and a monetary prize of \$30,500 on Monday, August 7 at the 2023 Annual Meeting. The American Accounting Association/J. Michael and Mary Anne Cook/Deloitte Foundation Prize is the foremost recognition of an individual who consistently demonstrates the attributes of a superior teacher in the discipline of accounting. The prize serves to recognize, inspire, and motivate members to achieve the status of a superior teacher. Each year up to three awards of \$30,500 each can be made in the categories of graduate, undergraduate, and two-year accounting degree programs.

Graduate - Christine Cheng, University of Mississippi

"I teach students with amazing potential. My goal is to motivate students to harness their potential, both in the classroom and after graduation. To realize my goal, I focus on three principles when designing my course and developing learning experiences.

First, I believe that students' efforts correspond with their interest. The beauty of teaching tax and data analytics is that there are unlimited opportunities to create learning experiences that spark students' interest. For example, in my graduate tax class I developed a project where students investigate how profitable firms can pay no tax. For my spring undergraduate individual tax class, I am developing a series of data analytics projects that have students explore how the Federal tax rules they learn affect them personally, both now, and in the future. My students frequently remark that they look forward to these learning experiences, because they want to know more.

Second, I recognize that students' potential is unique. Since I want students to harness their unique potential, I cultivate my classroom environment and develop learning experiences to provide students with a variety of ways to contribute. I have found that when students have opportunities to contribute in ways that take advantage of their unique potential, they are more likely to expand their potential beyond their current capabilities.

Finally, I realize that providing students with specific, formative, timely feedback is essential to support students as they work toward harnessing their unique potential and expanding beyond their current capabilities. My students consistently remark that they appreciate the effort, detail, and care I provide when reviewing their assignments."

Undergraduate - Wayne Thomas, University of Oklahoma

"My love for teaching is the reason I chose to be an accounting professor, and it's this aspect of my profession that I feel makes the biggest difference in the lives of others. In my responses below, I reflect on the materials I have used in class that symbolize my teaching philosophy—to engage students! When students are engaged, they are more likely to succeed. I am committed to student success.

With every assignment, every class, every office hour, and every interaction with a student, I challenge myself with fundamental questions: How can I bring the material alive to students? How can I make the complex seem simple? How can I help nonaccounting majors see the importance of accounting? How can I motivate the best students to pursue a major in accounting? How can I instill a passion for learning? How can I make learning exciting? I have seen a commitment to this approach work. It's not possible to capture fully in words the wonderful conversations I have had with students many years after taking my class.

Another important aspect of my teaching philosophy is to share all of my ideas and materials with other instructors. I have been fortunate to present my teaching materials at numerous conferences, workshops, webinars, and doctoral consortia over the years. This has led to many insightful conversations and exchanges of ideas. I am happy to share all of my ideas and teaching materials with any instructor that asks."

Two-Year College - Larry G. Stephens, Austin Community College

"My teaching philosophy is based on two major objectives: first of all, I view myself as a resource for my students to impart knowledge and wisdom; what I consider to be the technical skills of what I teach. I will often challenge my students to change their paradigm from being so heavily focused on a grade to define their success, to thinking about it in terms of being a lifelong learner and the acquisition of knowledge. I point out to my students that part of being a professional is always learning new things. A favorite quote that I use with my students is "Life doesn't come with a solutions manual." Accordingly, I am always learning new things from both my colleagues and my students and thus my classes are always evolving and changing in an effort to improve the experience for my students.

Secondly, is to be a role model for my students. Not only to teach them the required technical skills, but what it means to be a professional: the work ethic, professional behaviors, communication skills, teamwork and interpersonal skills. I also try to include in my courses my experiences of what it was like to work in the profession with over 20 years of experience as a professional accountant. I hope to bring to life more than just the rules in the textbook, but to create a holistic view of an accounting professional in the modern workforce. I want my students to be well-rounded, great accountants with a passion for what they do. Getting students involved in professional associations is one way that I try to spark that passion in accounting."

The 27th Annual Ethics Research Symposium

The 27th Annual Ethics Research Symposium was held on Sunday, August 6, 2023, preceding the AAA Annual Meeting. The Symposium encouraged thoughtful research on the ethical applications of teaching, practice, and/or business that ultimately benefits the individual, government, or society. This year's Symposium featured a variety of interactive sessions related to accounting ethics research, teaching accounting ethics, and professional responsibility and ethics. This year's co-chairs were Cassandra Rohland, University of Massachusetts-Lowell, and Michael Ruff, Northeastern University.

The opening address was presented by Linda Biek, Director for the International Ethics Standards Board of Accountants (IESBA), who spoke about Advancing the Centrality of Ethics for a More Sustainable Future.

In addition to the paper sessions, another highlight was a Whistleblowing Panel coordinated by Steve Mintz. Panelists included Cynthia Cooper (WorldCom whistleblower and a Time Magazine Person of the Year in 2002), Anthony Menendez (Haliburton Whistleblower), and Robert Conway, author of *Truth About Public Accounting – Understanding and Managing the Risks the Auditors Bring to the Audit*. 2023 Faculty-Student Collaborations in Accounting (FASTCA-23)

FASTCA is an all-day conference at the Annual Meeting that recognizes the importance of fostering faculty and student collaborations to facilitate memorable learning experiences for students, as well as to attract students to the accounting profession and accounting academy, and to connect the community of faculty conducting collaborative research and teaching.

2023 Global Emerging Scholars Research Workshop

The Global Emerging Scholars Research Workshop was held on Sunday, August 6, 2023 in conjunction with the 2023 AAA Annual Meeting. The workshop was held for scholars who are in the early stage of their research careers and are primarily focused on helping early career stage accounting scholars based in emerging countries.

The main objective of the workshop is to help scholars who do not have local senior leadership to develop their research. The scholars who attended the workshop presented their papers and received constructive feedback from senior mentors and their fellow scholars.

This year, eight workshop attendees had the opportunity to interact with renowned scholars of international standing and with fellow early career researchers. In addition, the workshop provided a platform for the discussion of research ideas and issues that potentially lead to future collaboration among attendees.
