After a summer school in Amsterdam in 2015 and earlier editions of the conference in Leuven (2017) and Maastricht (2019), we are very excited to now invite you to magical Seville.

We invite experimental papers from all of subfields of accounting, including auditing, financial accounting, management accounting, accounting information systems, and tax. Discussants from the community will be invited to discuss each paper. We will also accept a limited number of extended proposals for experiments that have not been run yet.

We also organize a PhD colloquium during which students get feedback on their proposals or papers.

Submission

To submit a paper for the conference, please send your full paper or proposal to enearmail@gmail.com. Make sure the title page contains the names and affiliations of all co-authors. The submission deadline is March 31, 2022.

To encourage interaction among participants, a limited number of around 30 papers will be accepted for presentation. The organizing committee will inform you about the decision around April 30.

Date

The PhD colloquium takes place on Thursday, July 7, 2022, in the morning. The conference will start on Thursday July 7, 2022 around noon and will end in the late afternoon of Friday July 8, 2022. There will be an informal early bird reception on the evening of Wednesday, July 6.
