Submissions

Papers, full or developmental (up to 7,000 words), are invited on the above-mentioned topics and on other aspects of financial reporting and business communication. Papers may take empirical, theoretical and conceptual approaches, including case studies or experiments. Papers (please mark as FULL or DEVELOPMENTAL paper) should be submitted by emailing FRBC@bath.ac.uk. The submission deadline is 30 April 2023.

For doctoral students wishing to present in the doctoral stream, a structured abstract of up to 1,000 words should be submitted. A Sue Hrasky Scholarship is available for 2023 to doctoral students in the doctoral stream. This comprises a doctoral fee waiver, receipted travel within the UK to the conference, subsistence and accommodation costs related to the conference. All submissions by doctoral students will be considered for the scholarship. The award of the Scholarship will be communicated via email. Abstracts (please mark as DOCTORAL) should be submitted by emailing FRBC@bath.ac.uk. The submission deadline is 30 April 2023.
