Nancy Uddin – Monmouth University

Nancy Uddin is an Associate Professor of Accounting at Monmouth University, Leon Hess Business School. Nancy is the Department Chair and began her current term July 2021, previously she served as Department Chair from 2014-2017. She has served on the New Faculty Search Committee, Tenure and Promotion Committee and the most recent Dean Search Committee. Nancy is a Past President of the Strategic and Emerging Technology Section and the Mid-Atlantic Region of the American Accounting Association. Her areas of expertise include auditing, accounting information systems, and financial accounting.

Mary Keener – The University of Tampa

Dr. Mary Keener is an Associate Professor of Accounting at the Sykes College of Business at The University of Tampa, where she has worked since 2008. Dr. Keener earned her Bachelor's degree in Math Secondary Education at The University of Toledo in 1999. She earned her Master's of Science in Accounting and PhD in Accounting with a Statistics Minor at Kent State University in 2000 and 2007. Dr. Mary Keener served as the faculty advisor for Beta Alpha Psi from 2008 to 2017 and helped to guide the chapter to many regional and national awards. Dr. Keener's primary area of both research and teaching is financial accounting. Dr. Keener teaches financial accounting at the principles, intermediate, and graduate levels. Dr. Keener's research interests lie in capital markets research. She has published several articles examining the value relevance of restructuring charges and their impact on analyst forecast accuracy.

Diana Falsetta – University of Miami

Diana Falsetta is an associate professor at the University of Miami Herbert Business School. She received her BS in Accounting and Finance from Florida State University, MPA in Taxation from The University of Texas at Austin, and PhD from the University of South Carolina. She is active in the American Accounting Association having served on the AAA/Deloitte Foundation/J. Michael Cook Doctoral Consortium Committee and as President, Vice President, Secretary and Trustee of the American Taxation Association. She is also active in the AICPA, currently serving on the AICPA's Tax Compliance and Planning Task Force to develop the Model* Curriculum for taxation. Her research focuses on taxpayer judgment and decision making and tax policy. She has published in *The Accounting Review*, *Contemporary Accounting Research*, and *The Journal of the American Taxation Association*. She served as associate editor at *The Journal of the American Taxation Association* and *Behavioral Research in Accounting*.
