

Q1 Do you expect future demand for and interest in business sustainability practice to:





Q2 Do you expect future demand for and interest in business sustainability education to:





Q3 Are you currently (or within the past several years) teaching or overseeing courses in Business Sustainability?





Q4 Do you think there is a need for a new textbook on business sustainability and sustainability reporting and assurance?





Q5 Do you think there is a demand for and interest in establishing the SAS?






Q7 Are you interested in engaging in the establishment of the SAS?







Q11 Which of the following best describes your college or university? Please select one.






