



EXTRACTS FROM CONSTITUTION AND BY-LAWS.

(CONSTITUTION) ARTICLE II.

MEMBERS AND THEIR ELECTION.

SECTION I. "The admission and election of members (other than Honorary) shall be determined by the Board of Trustees, who thy, in their absolute discretion, by resolution passed by a majority of the members present and voting, refuse to admit or iterations and the second seco to uther degree of membership whom they may deem unfit and unsuitable; or suspend for future consideration any application for admission for such time as they may deem desirable; they may re-admit to membership any person who has ceased to be a member of the Association by resignation, provided satisfactory causes for such resignation and re-admission be submitted to them." SEC. 3. The members shall be divided into two classes: --Pellows and Associates.

SEC. 5. The Fellows shall consist of accountants who have been in continuous practice on their own account for three years pre-Vious to their admission, and who must pass such examination as to their fitness as shall be prescribed by the Board of Trustees, and who shall be citizens or have declared their intentions to become such. SEC. 5. The Associates shall consist of Junior Certificated Accountants, clerks in the employment of Members of the Association

and of such as are eligible to membership and who apply to be admitted Associates.

(BY-LAWS) ARTICLE VI.

INITIATION FEES AND DUES

The following shall be the Initiation Fees: SECTION 1. By a Fellow† on admission, without becoming an Associate, \$25.00.

SEC. 2. By an Associate on becoming a Fellow. \$15.00.

SEC. 3. By an Associate on admission, \$10.00. The following shall be the Annual Dues:

By each Fellow, $\sharp_{10,00}$ and by each Associate, $\sharp_{5,00}$. Such fee, hereinafter styled "The Annual Certificate Fee," shall be due and payable in January of each year, or at the date of a member's election or admission, or beginning to practice, and until payment thereof no annual Certificate of Membership shall be issued. Such dues to terminate on the 3tst day of December of each year, and to be apportioned in the first instance to the end of the fiscal year.

†A "Fellow" must be in practice for himself.

Update from Dr. Royce Kurtz on eGrove

2024 Summer Digitization Projects:

- Transcripts of AICPA Annual meetings and the semi-annual Council meetings, plus speeches and committee reports presented at the annual meetings
 - Transcripts and minute books go back to 1887.
 - Started with 2016 meetings (going forward all transcriptions are digital only) and now approximately halfway done, in the mid-1950s.
 - Hope to be finished by Christmas. (Over 800 transcripts, committee reports, and speeches at annual meetings are already available in eGrove.)
- Correspondence of the AAPA (1887-1917) and the AIA (1917-1957)
 - Roughly 350 letters are now in eGrove out of approximately 1,000.
- Journal of Accountancy
 - Hope to finish first tranche of issues 1905-1940 by end of summer.
 - Then it is on to the war years! We have already posted 3,100 *Journal of Accountancy* articles in eGrove, and they have, to date, been downloaded 98,443 times.



Update from Dr. Royce Kurtz on eGrove

New Digitization Project:

Tax Adviser – No one has digitized the first 17 years, 1970-1986. We will set up and start scanning these years this summer, another project that will span several years.

Completed Digitization Project:

AICPA's Uniform CPA examination. Selected questions and unofficial answers indexed to content specification outline, 1979-2000 (24 volumes)

The AICPA series, *Index to Accounting and Auditing Technical Pronouncements*, 1977-1995 (17 fat volumes). The publication provided a subject index to over thirty different authoritative and semi-authoritative sources for accounting and auditing standards.
