**Theresa Libby, University of Central Florida**

Theresa Libby is the EY Professor of Accounting in the Kenneth G. Dixon School of Accounting at the University of Central Florida. She received her PhD from the University of Waterloo and has been recognized as a Fellow of CPA Ontario. Her research focuses on managers' use of accounting information for decision-making, the effects of budgeting processes on individual and organizational performance, accounting ethics and innovation in management accounting systems. She has previously served as the President of the Management Accounting Section and as a member of AAA Council. Professor Libby has published articles in leading journals including *The Accounting Review*, *Accounting, Organizations and Society*, and *Contemporary Accounting Research*. She currently serves as an Editor at the *Journal of Management Accounting Research* and sits on the Editorial Boards of *The Accounting Review*, *Accounting, Organizations and Society*, *Contemporary Accounting Research*, and *Behavioral Research in Accounting*. Professor Libby has previously served as Senior Editor of *Behavioral Research in Accounting*, Deputy Editor-in-Chief of *Contemporary Accounting Research* and Associate Editor at *Management Accounting Research*.

Shane Stinson is a Professor and John L. and Margaret E. Rhoads Chair in Accounting at the University of Alabama. His research focuses primarily on how tax information and incentives affect individual savings and investment decisions. He has published in *The Accounting Review*, *Contemporary Accounting Research*, *Review of Accounting Studies*, *The Journal of the American Taxation Association*, *Behavioral Research in Accounting*, *The ATA Journal of Legal Tax*
