IAS Activities – 2022 Annual Meeting

The 2022 Annual Meeting was successfully held on July 29 to August 3, 2022 (in-person sessions) and August 11-12, 2022 (virtual sessions). The International Accounting Section's program was organized by the co-chairs, Jay Junghun Lee (University of Massachusetts Boston) and Elizabeth Gutierrez (Universidad de Chile). There were 7 concurrent/dialogue sessions with 31 paper presentations and 5 panel discussions during the in-person meeting, covering topics such as research design advantages in international accounting research, publishing international accounting research, emerging issues in international taxation research, declining enrollment in accounting and solutions, and sustainability and integrated reporting. In addition, there were 5 concurrent/dialogue sessions with 17 paper presentations and 2 panel discussions during the virtual meeting, covering topics such as IFRS 17 insurance accounting issues and international effects on accounting. There were 54 reviewers, 28 discussants, 19 moderators, and about 550 attendees in the concurrent sessions and panel discussions of the International Accounting Section at the annual meeting.

IAS Activities – 2023 Midyear Meeting

Our 2023 midyear meeting, which was jointly organized with the AIS and SET sections, was held in Las Vegas from January 26th to 28th. The IAS program was coordinated by co-chairs Chuong Do (University of Nevada Reno) and Jeff Chen (Texas Christian University). The meeting began with the Annual PhD Student/New Faculty Consortium, which was led by Linda Myers (University of Tennessee Knoxville) and Emily Shafron (Texas A&M University).

The meeting included a luncheon featuring Gene Lee, Senior Vice President of Data Analytics at Caesars Entertainment, who shared his experiences applying data analytics to various aspects of the casino business. Additionally, the program had two general sessions addressing important issues related to student enrollment declines and international cybercrime. There were 14 concurrent sessions featuring 32 paper presentations, covering a range of topics such as the PCAOB's international inspection program, IFRS adoptions around the world, the SEC's comment letter process, global ESG risks, and financial reporting implications of cross-listings. Overall we had 30 presenters, 29 reviewers, 28 discussants, and 13 moderators participating in the conference.

IAS Activities Report by Committee Chairs for the 2023 Midyear Meeting

This report contains summaries of each IAS committee's activities to date and activities planned for the remainder of the year.

Annual Meeting Program Committee Chairpersons: Jay Lee & Francesco De Luca

We initiated our work starting from an email exchange with the President Gia Chevis on October 27th of 2022. Following the acceptance of this task for the 2023 annual meeting, we recruited three committee members: Joseph Zhang, Jeff Zeyun Chen, and Jiwoo Ryou. We held two coordination meetings to plan our activities (December 5th of 2022 and January 16th of 2023). Jay Lee also contacted the President about an IAS luncheon speaker and invited co-chairs of research committee, teaching and curriculum committee, and practice issues committee to submit panel proposals. **Annual Meeting Submissions by January 18th** Concurrent sessions: 53 research papers have been submitted. Panel sessions: 7 proposals have been submitted. Work-in-progress: Committee members are assigning reviewers to papers (deadline January 31st). The committee will be requesting panel proposal submitters to provide more details of panels (e.g., panel moderators and members) by February 28th.

JIAR Doctoral Consortium Chairperson: Linda Myers

Our June 2022 Consortium on Zoom was a great success with 2 sessions attended by 49 PhD students and new faculty. Leaders included Dan Bens, Ling Lisic, Dereck Barr-Pulliam, and many other section members. Panels discussed "Research and the Review Process" as well as "Job Search and Early Career Strategies". The coming summer's consortium at East Anglia still has many open slots but I have lined up a great group of faculty leaders. Please encourage PhD students and junior faculty in your networks to send applications via email directly to me.

Midyear Conference Chairpersons: Chuong Do & Jeff Chen

This year we received a total of 45 paper submissions. There were 82 submissions last year. We received fewer submissions this year likely because we switched to an in-person meeting. The number of papers accepted for presentation is 35. Out of these accepted papers, 34 papers were scheduled to be presented in the meeting and the other paper was withdrawn by the authors, as of January 16th 2023. The acceptance rate is 78.0%, similar to prior meetings. Given the smaller number of submissions this year, we did not divide the submissions into tracks this year. The cochairs assigned reviewers for all submissions and made the accept/reject decisions based on reviewer comments. In addition to the concurrent sessions, we also had 2 panel sessions, one jointly with the other sections and one focused on teaching and curriculum. Regarding the volunteer roles, we had 32 discussants (one paper intentionally without a discussant and one discussant serving twice), 14 moderators, and 29 reviewers participated in the review process, and at current sessions. The research committee selected 2 outstanding papers. The meeting co-

chairs selected 4 outstanding reviewers.

This year's meeting will be held jointly with the AIS and SET sections. We worked closely with Daniel O'Leary and Margarita Lenk, our counterparts at both AIS and SET, to organize the program. Except for the joint plenary sessions, our concurrent sessions are separated. While we enjoyed working with AIS and SET's various chairs in organizing the conference, we note that there is little topical overlap between our sections, preventing inclusion of joint research sessions. We note that only one presenter and one discussant on our program are members of AIS or SET but not ours.

While Covid is a lesser threat this year than it was in the previous year, we continue to receive inquiries about whether there is a virtual option to participate in the meeting. Finally, 16 out of 34 papers on the program will be presented by authors based outside of the US.

Midyear Conference Doctoral Consortium Chairperson: Linda Myers

18 PhD students and 7 new faculty applied to the consortium at this year's midyear meeting. Breakout and panel leaders included Kim Westermann, Brian Burnett, Long Chen, Bowe Hansen, Chuong Do, Laura Swenson and other section members. Panels discussed "Early Career Strategies" and we had presentations on "Generating Research", "Evaluating Research", "Service Opportunities", and a "Focus on Teaching", as well as an Editor's panel and breakout group discussions. Lucy Chen has asked me to organize next year's consortium. I would like to see even more attendees so please advertise in your networks.

Nominations Committee Chairperson: Judy Beckman

The committee submitted a report to President Gia Chevis in October 2022 with the timeline for our election process and recommended improvements from our predecessor which we included in our nomination solicitation emails that ran from October 2022 to January 2023. As of the January 12 closing date, we received nominations for a full slate of elected positions for individuals who are confirmed to be willing to serve in these roles. Our nominations committee will meet soon to send the nominations to AAA for our election cycle which begins in March.

Outstanding Section Service Award Chairperson: Eva Jermakowicz

This committee selected the recipient of the 2023 Ian Hague Award for Outstanding Service.

Outstanding Dissertation Award Chairperson: Sudipta Basu

Nominations are being accepted for this award.

Outstanding Educator Award Chairperson: Mahendra Gujarathi

Research Committee Chairpersons: Inder K. Khurana & Feng Chen

This committee nominated two papers for the 2023 AAA IAS Mid-Year Meeting "Best Paper Award", submitted AAA Annual Meeting Panel Proposals, "Publishing International Accounting Research Perspectives and Directions of International Audit Research" and "Perspectives and Directions of International Audit Research".

Communications Committee Chairperson: Weishi Jia

This committee is preparing the winter newsletter of IAS that summarizes the IAS activities.

Teaching and Curriculum Committee Chairpersons: Laura Swenson & Mohammad Nurunnabi

We have completed the following tasks thus far this year:

- 1. Midyear Meeting: We have organized a panel called "Accounting Case Study Best Practices and Classroom Application". It will be held on Friday, January 27 from 1:15-2:45 PST. Panelists included: Natalie Tatiana Churyk (PwC Professor of Accountancy at Northern Illinois University and Editor-in-Chief of Journal of Accounting Education), Timothy Eaton (Arthur Andersen Alumni Professor of Accountancy, Miami University), Jason Porter (Scholarly Associate Professor of Accounting at Washington State University's Carson College of Business and Associate Editor for the IMA Educational Case Journal (IECJ)) and Jeff Wilks (EY Professor of Accounting, BYU School of Accountancy). The purpose of this session is three-fold: (1) to discuss "best practices" when creating a case study, including those addressing international accounting issues, (2) tips for using case studies in the classroom and (3) to introduce and/or review with the audience case study resources from the Profession. We encourage everyone to attend and participate!
- 2. **Annual Meeting:** We have submitted two panel proposals to the chairs for consideration.
- 3. As we go through this year, we have started to put our **committee procedures in writing** to make it easier for subsequent members to complete the tasks of this committee.
- 4. **Syllabi update:** With many schools in the US changing curriculum in light of the new CPA Blueprint, we have decided to wait to reach out to schools to ask for updated syllabi on international accounting topics.
