### **President's Letter**



I am deeply honored to serve as the president of the International Accounting Section (IAS) of the American Accounting Association (AAA) for 2024-2025. As the first IAS president from Australia, this is a role I accept with great sense of responsibility.

I would like to begin my tenure by extending my gratitude to Lucy Chen for her leadership and dedication to the Section and our shared vision to "serve as a forum to share and disseminate information about international accounting, education, and research issues and to serve as a point of entry into AAA for international faculty and doctoral students, and increase community of international academics, practitioners, standard setters and researchers".

During Lucy's tenure, a Lifetime Contribution to International Accounting Research Award was launched, spearheaded by Sudipta Basu and his team. The Award recognizes an individual who has made notable contributions to international accounting research over the course of his/her career. The inaugural recipient of the Award was Mary Barth for her contributions to international accounting research. Her keynote address at the 2024 IAS Midyear Meeting Luncheon about unresolved financial reporting issues outlined opportunities for international accounting research; it is now published in our Section journal, *Journal of Intentional Accounting Research* (<a href="https://doi.org/10.2308/JIAR-2024-037">https://doi.org/10.2308/JIAR-2024-037</a>).

The year 2025 promises to be an exciting year for international accounting research. It will mark 20 years since the adoption of International Financial Reporting Standards (IFRS) as domestic financial reporting standards by countries such as those in the EU, Australia, and the UK. I can envisage many opportunities, both in terms of research and practice; for example, has the adoption of IFRS change multinational corporations' financial reporting practices? Has there been any practical challenges due to the co-existence of IFRS and US GAAP? I am eager to discover the future direction of international accounting research.

I am pleased to confirm that the IAS will host three conference meetings to bring together the international accounting faculty and doctoral students, as well as practitioners, standard setters and professional and academic associations from all over the world.

Our 2025 IAS Midyear Meeting will be held on 25-27 January at Florida International University (FIU), Miami FL. Special thanks to Mark Myring from FIU for hosting and to Maria Rykaczewski and Brian Burnett for their hard work in preparing for the meeting as the Midyear Meeting Co-Chairs. I also thank Linda Myers for chairing the PhD/New Faculty Consortium during the Midyear Meeting – your continuing support for our section is much appreciated!

In June/July, the 12th Journal of International Accounting Research (JIAR) Conference will be held in Casablanca, Morrocco. What a wonderful opportunity to experience one of the most beautiful cities in the world and, of course, to meet our section members to discuss international accounting research!

The Annual Meeting will be held in Chicago IL from 2-6 August 2025. Our Co-Chairs for the Meeting are Long Chen and Jiwoo Ryou who are already starting to plan for the Meeting. Please consider submitting your manuscripts and panel session proposals, as well as volunteering as reviewers, discussant and moderators.

I hope to see many of you in Miami, Casablanca and Chicago in 2025.

## IAS Activities – 2024 Annual Meeting

The 2024 Annual Meeting was successfully held from August 10 to August 14, 2024. The International Accounting Section's program was organized by the co-chairs, Long Chen (George Washington University) and Francesco De Luca (University G. D'Annunzio of Chieti-Pescara, Italy), with the collaboration of the other committee members, Jiwoo Ryou (West Virginia University), Joseph Zhang (University of Memphis), and Ling Zhou (University of New Mexico). There were 10 concurrent/dialogue sessions (7 concurrent and 3 dialogue) with 34 paper presentations and 5-panel discussions, covering topics such as sustainability reporting, risk disclosures, perspectives from the national accounting standards setters, and teaching the next generation, the latter being one of the AAA panel sessions. There were 64 reviewers, 13 discussants, 9 moderators, and attendees in the concurrent sessions and panel discussions of the International Accounting Section at the annual meeting. In addition, the committee arranged the IAS luncheon scheduled for Monday, August 12, 2024. The luncheon included the keynote speech by Paul Munter, Chief Accountant at the SEC, and the award ceremony.


