SET Annual Meeting

As part of the AAA, the SET offers several research paper sessions and panel discussions as well as a business and networking breakfast during the AAA Annual Meeting, the premier conference among accounting academics.

Annual Transformative Technologies Workshop

Designed for everyone interested in how accounting practice is evolving with technological advancements, the annual Transformative Technologies Workshop in Accounting features lively discussions between academics and industry leaders whose products and services promise to transform the practice of accounting. Recent workshops featured quantum computing, blockchain and RegTech applications, cognitive technology, ransomware, as well as data and algorithms in sustainability (ESG) reporting – each showcasing a different dimension of the changing role of accountants and accounting information for decision making. This workshop is held online.

Annual SET Research Workshop

The SET Research Workshop, held on the Saturday before the AAA Annual Meeting, brings together established SET researchers and up-and-coming Ph.D. students to present early-stage research and receive feedback. It is a must-attend event for anyone interested in emerging technologies in accounting. We waive the registration fee for PhD students.

Annual SET Midyear Meeting

The section supports an annual Midyear Meeting, usually in conjunction with the Accounting Information Systems section. Like the Annual Meeting, the midyear fields a series of paper sessions featuring emerging research results and panel sessions on topics ranging from teaching emerging technologies, industry updates, standards, and many other topics.

JETA-C (JETA Conference)

This conference, held in conjunction with the annual Midyear Meeting, is themed on a particular emerging issue, such as blockchain. Papers accepted to the conference are fast-tracked for publication in the Journal of Emerging Technologies in Accounting (JETA) in order to disseminate new developments as quickly and widely as possible.

Annual Value Modeling and Business Ontologies Workshop – Co-sponsor

The goals of the VMBO workshop series are to connect researchers with an interest in value modeling and business ontology in order to present and discuss the current state of enterprise or business modeling and to identify key areas for further research, including but not limited to innovative business model design, systemic trust for value exchanges, ontologies for modelling economic concepts and institutions, and value-aware systems design.
